1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to them that there has been a breach of planning control, under section 171A(1)(a) of the above act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The annex at the end of the notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at 91 Abbey Road, Grimsby, North East Lincolnshire shown edged red on the attached plan ("the land")

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission the erection of a domestic garage and store.

# 4. REASONS FOR ISSUING THIS NOTICE

It appears that the breach of the above planning control has occurred within the last four years.

The retention of the garage/garden store, by reason of its design and the materials used in its construction, does not reflect the architecture of the main building. The development thus presents an architecturally discordant feature detrimental to the visual amenities of the Wellow Conservation area. The building is thus contrary to Policy GEN1 and BH1 of the North East Lincolnshire Local Plan Adopted November 2003.

The Council does not consider that planning permission should be given because planning conditions could not overcome these objections.

Demolish the garage/garden store and remove from the land all resultant debris and demolition material.


#### WHAT HAPPENS IF YOU DO NOT APPEAL
