ENFORCEMENT NOTICE – OPERATIONAL DEVELOPMENT

ISSUED BY: NORTH EAST LINCOLNSHIRE COUNCIL

1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to the Council that there has been a breach of planning control, under section 171A(1)(a) of the above act, at the land described below. The Council considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. THE LAND AFFECTED

Land at 10 Eastfield, Humberston, North East Lincolnshire shown edged red on the attached plan ("the land")

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission the erection of a garage, wall, fence and gates shown in blue on the attached plan ('the garage, wall, fence, and gates').

4. REASONS FOR ISSUING THIS NOTICE

It appears that the breach of the above planning control has occurred within the last four years.

The wall, fence and gates are greater than 1 metre in height and as such form a discordant feature in the street scene to the detriment of the visual amenity of the character and appearance of the area.

The garage and boundary treatment by reason of their size, location and construction materials have an adverse effect on the appearance of the area and particularly the public enjoyment of the adjacent public footpath and are thus contrary to saved Policy GEN1 of the North East Lincolnshire Local Plan 2003..

Planning permission has been refused for the garage, wall, fence and gates on 18 October 2006 (DC/785/06/HUM) and 13 February 2008 (DC/665/07/HUM) because planning conditions could not overcome these objections.

5. WHAT YOU ARE REQUIRED TO DO

Remove the garage, wall, fence and gates from the above property known as 10 Eastfield, Humberston, Cleethorpes.

6. TIME FOR COMPLIANCE

28 days after this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 6/10/08 unless an appeal is made against it beforehand.

ANNEX

YOUR RIGHT OF APPEAL

You can appeal against this notice, but any appeal must be received, or posted in time to be received, by the Secretary of State before the date specified in paragraph 7 of this notice. The enclosed booklet "Enforcement Appeals – A Guide to Procedure" sets out your rights. Read it carefully. You may use the enclosed appeal forms. If you decide to appeal, one copy of the form is for you to send to the Secretary of State, together with a copy of the enforcement notice. A spare copy is enclosed for this purpose. The second copy of the appeal form and the notice should be sent to the Council. The other is for you to keep as a duplicate for your own records.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on the date specified in paragraph 7 of this notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period(s) specified in the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
