1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to the Council that there has been a breach of planning control, under section 171A(1)(a) of the above act, at the land described below. The Council considers that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The annex at the end of the notice and the enclosures to which it refers contain important additional information.

#### 2. THE LAND AFFECTED

Land at 26 Orion Way, Grimsby, North East Lincolnshire shown edged red on the attached plan ("the land")

3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission the erection of a fence, shown in blue on the attached plan ("the fence").

# REASONS FOR ISSUING THIS NOTICE

It appears that the breach of the above planning control has occurred within the last four years.

The fence is a discordant feature in this open plan estate, detracting from the visual amenity of the street scene. If approved, the decision would set a precedent that would make it difficult for the Council to refuse other similar applications and result in further degradation of the character and appearance of the area. As such the fence is contrary to national planning policy and saved Local Plan Policy GEN1 of the North East Lincolnshire Local Plan 2003.

Planning permission has been refused for the development on 9<sup>th</sup> October 2007 (DC/715/07/YAR) and 20<sup>th</sup> December 2007 (DC/1351/07/YAR) because planning conditions could not overcome these objections.

## 5. WHAT YOU ARE REQUIRED TO DO

Remove the fence from the front of the above property known as 26 Orion Way, Grimsby.

## 6. TIME FOR COMPLIANCE

28 days after this notice takes effect.

# 7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 2.3/3/0.8. unless an appeal is made against it beforehand.


#### **ANNEX**

# WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this enforcement notice, it will take effect on the date specified in paragraph 7 of this notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period(s) specified in the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.




Title: Land at 26 Orion Way, Grimsby


