3. THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL

Without planning permission the erection of a wooden enclosure to create a balcony on an existing roof, shown in blue on the attached plan ("The Enclosure")

4. REASONS FOR ISSUING THIS NOTICE

It appears that the breach of the above planning control has occurred within the last four years.

A planning application DC/391/05/WOL for the installation of a metal fence on an existing flat roof was refused on the grounds of "loss of privacy for nearby occupiers". A subsequent appeal to the Planning Inspectorate upheld this decision.

Following this it was brought to the attention of the Local Planning Authority that an enclosure had been erected on the roof and it was found that, the enclosure exceeded 2 metres above the ground level. Several requests have been made to the occupiers of the property requesting that they remove the enclosure. To date this request has not been complied with.

The Council does not consider that planning permission should be given because planning conditions could not overcome these objections.

WHAT YOU ARE REQUIRED TO DO

Remove from the existing flat roof the wooden boxes which form the roof top enclosure.

TIME FOR COMPLIANCE

28 days after this notice takes effect.

WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 1st January 2007 unless an appeal is made against it beforehand.


