North East Lincolnshire Local Plan 2013 to 2032 Adoption Statement

In accordance with the above regulations notice is hereby given that North East Lincolnshire Council formally adopted the *North East Lincolnshire Local Plan 2013 to 2032* (the Plan) on **22 March 2018**.

The Plan sets out the Council's vision, spatial strategy and policy framework for development across the Borough up to 2032, including why, where and how the Borough will grow. The Plan is a plan for growth and aims to ensure North East Lincolnshire becomes a sustainable location in which people can live, work, and enjoy their recreation, both now and in the future.

For the avoidance of doubt the Plan replaces the following documents:

- North East Lincolnshire Local Plan, including Minerals and Waste Policies (adopted November 2003, saved policies (2007)); and,
- Supplementary Planning Guidance (SPG) including:
 - Conversion of Properties to Flats and Houses in Multiple Occupation (2002);
 - Mobility and Parking Standards (2004);
 - Contributions to Education Facilities (2005);
 - Investment through Growth (2005);
 - o Landscape Design (2005); and,
 - o The Grimsby Strategic Framework (2005).

Examination

The Local Plan was the subject of an independent examination conducted by Planning Inspector Kath Ellison BA MPHIL MRTPI who was appointed by the Secretary of State. In her report, published in February 2018, the Inspector confirmed, subject to a number of main modifications the Plan was sound and recommended its adoption. The recommended main modifications have been included in the adopted Local Plan document which now carries full weight in the consideration of planning applications and replaces the *North East Lincolnshire Local Plan, including Minerals and Waste Policies* (November 2003).

High court challenge:

Any person aggrieved by the North East Lincolnshire Local Plan may make an application to the High Court under Section 113(3) of the *Planning and Compulsory Purchase Act 2004* on the grounds that:

- 1. The North East Lincolnshire Local Plan 2013 to 2032 is not within the powers conferred by Part 2 of the Planning and Compulsory Purchase Act 2014; or,
- 2. A procedural requirement has not been complied with.

Any such application must be made not later than the end of the period of six weeks starting with the date on which the Local Plan was adopted (22 March 2018).

In accordance with Regulation 26 this Adoption Statement has been sent to the Secretary of State.
