### **CONTRIBUTION TO OUR AIM**

By adopting the local validation lists, this will support the Council's plan by supporting a stronger economy and encouraging a sustainable community.

### **EXECUTIVE SUMMARY**

- 1. Paragraph 44 of the National Planning Policy Framework (NPPF) sets out that Local Planning Authorities should publish a list of their information requirements for applications, which should be proportionate to the nature and scale of development proposals and reviewed every 2 years.
- The National Planning Policy Guidance (NPPG) provides further advice regarding Validation setting out that a local planning authority may request supporting information and that its requirements should be specified on a formally adopted local list which has been published on its website.

### RECOMMENDATIONS

It is recommended that the local validation lists be adopted by Planning Committee.

## **REASONS FOR DECISION**

The lists are required to enable the public to clearly see the requirements of the Authority and for transparency and consistency in our validation and registration of applications. Adopting the lists will aid in better clarity and service for customers and a better quality of applications and thus more sustainable and higher quality development.

## 1. BACKGROUND AND ISSUES

- 1. It is important that a planning authority seeks all relevant and necessary information to enable an informed decision to be made on any planning application. As set out above in the Executive Summary, the NPPF and the NPPG provide guidance on the scope and need for a local validation lists for planning applications. The current local lists are more than two years old and need to be reviewed.
- 2. The current lists were reviewed by Development Management officers in

consultation with other council specialists including Environmental Health, Trees and Woodlands, Highways and Heritage.

- 3. The new draft lists were provided for comments throughout
  July and early August 2020 to planning agents and were published on the
  Council website.
- 4. Only one written representation was received which is appended at Appendix1. This has been accounted for in the most recent versions of the checklists.

### 5. RISKS AND OPPORTUNITIES

Without formally adopted and up-to-date Local Validation Lists the Council is vulnerable to challenge whilst validating substandard submissions. This vulnerability could result in appeals for failure to validate and subsequent costs claims. Alternatively, if substandard submissions are validated due to the lack of a robust list then it is potentially more challenging to understand the exact nature of the development proposed and its potential impacts.

### 6. OTHER OPTIONS CONSIDERED

No other options required consideration.

There are potential positives/negative reputational implications for the Council resulting from the decision. However, it is considered these have been mitigated by public consultation being undertaken.
