## The North East Lincolnshire Borough Council (Abbey Area Residents Parking Scheme) (No. 18-22) Order 2019

Notice is hereby given that on 20 March 2020 North East Lincolnshire Borough Council made the above Traffic Regulation Order under powers contained in the Road Traffic Regulation Act 1984 the effect of which will be to:-

- 1. Introduce shared Permit Holder and 2 hour Limited Waiting parking which operates Monday Saturday between the hours of 8am and 6pm in sections of the following locations:
- Manor Avenue
- Wellowgate
- Abbey Drive East

- Abbey Road
- St Olafs Grove
- Abbey Drive West

- 2. Introduce Limited Waiting parking (2 hours No return within 2 hours) which operates Monday to Saturday 8am 6pm, in sections of Abbey Park Road between its junctions with Abbey Road and Abbey Drive West.
- 3. Convert existing Prohibition of Waiting restrictions (No Waiting: Monday to Saturday 8am 6pm) to 24hr Prohibition of Waiting (No Waiting: At Any Time) at the following locations:
- Abbey Road (Northerly kerbline) between property no.s 79-81
- Abbey Road (Northerly kerbline) at its junction with Wellowgate
- Abbey Road (Southerly kerbline) at its junction with Wellowgate
- Abbey Road (Southerly kerbline) between Ainslie Street and Wellowgate.
- Abbey Road junctions with Abbey Drive East, Abbey Drive West, Abbey Park Road, Manor Avenue and Welholme Avenue
- Wellowgate junction with Abbey Drive East
- Wellowgate adjacent to property no.s 56 & 58 Wellowgate
- Wellowgate adjacent to car park access within vicinity of property no. 45 Wellowgate
- St Olafs Grove along its westerly kerbline from its junction with Abbey Drive East
- Abbey Drive East junctions with Abbotsway and St Olafs Grove
- Abbey Drive East adjacent to car park access of Cyril Cooper Court
- Abbey Drive East adjacent to property no. 17 Abbey Drive East
- Abbey Drive West junction with Abbotsway
- Abbey Drive West (North Westerly kerbline) opposite its junction with Abbotsway
- Abbey Park Road at and opposite its junction with Abbey Drive West
- Abbey Park Road adjacent property no.s 2 & 2a Abbey Park Road

- 4. Introduce 24hr Prohibition of Waiting restrictions (No Waiting: At Any Time) at the following locations:
- Manor Avenue (North Easterly kerbline) adjacent to property no.s 2 & 4 Manor Avenue
- Abbey Drive East (Westerly kerbline) between its junctions with Abbey Road and Abbotsway
- Abbey Drive West (Easterly kerbline) between its junctions with Abbey Road and Abbotsway
- Abbey Drive West (Southerly kerbline) adjacent to property no.s 23 & 25 Abbey Drive West
- 5. Convert existing Prohibition of Waiting restrictions (No Waiting: Monday to Friday 10am 11am to No Waiting: Monday to Saturday 10am 11am and 2.30pm 3.30pm at the following locations:
- Abbotsway (Westerly to North Easterly kerbline) adjacent to property no.s 2 to 14 Abbotsway.
- Abbotsway (Easterly to Southerly kerbline) adjacent to property no.s 1 to 23 Abbotsway.
- 6. Convert existing Prohibition of Waiting restrictions (No Waiting: Monday to Friday 10am 11am to 24hr Prohibition of Waiting (No Waiting: At Any Time) along a section of the South Westerly kerbline of Abbotsway between property no. 23 Abbotsway and its junction with Abbey Drive West.
- 7. Consolidate existing 24hr Prohibition of Waiting (No Waiting: At Any Time) restrictions at the following locations:
- Manor Avenue (both kerblines) within the vicinity of property no.s 22 & 29 Manor Avenue.
- Abbey Road (North Westerly kerbline) adjacent to property no.s 1 to 5 Abbey Road.
- Abbey Drive East (both kerblines) between the westerly kerbline of Ainslie Street and property no. 19 Abbey Drive East.
- 8. Consolidate existing Prohibition of Waiting (No Waiting: Monday to Saturday 8am 6pm) restrictions at the following locations:
- Abbey Road (North Westerly kerbline) adjacent to property no.s 31 to 51 Abbey Road.
- Abbey Road (North Westerly kerbline) adjacent to property no.s 53 to 55 Abbey Road.
- Abbey Road (North Westerly kerbline) adjacent to property no.s 55 to 67 Abbey Road.
- Abbey Road (North Westerly kerbline) adjacent to property no.s 95 to 99 Abbey Road.
- Abbey Road (South Easterly kerbline) adjacent to property no.s 4a Abbey Road to 1 Abbey Drive East.
- Abbey Road (South Easterly kerbline) adjacent to property no.s 10 to 12 Abbey Road
- Abbey Road (South Easterly kerbline) adjacent to property no.s 2 Abbey Park Road to 20 Abbey Road.
- Welholme Avenue (both kerblines) adjacent to property no.s 5 to 7 Welholme Avenue.

The Order will come into force on the 01 May 2020.
