The Borough of North East Lincolnshire Council (B1203 – East Ravendale to Waltham) (Speed Limits) (No. 18-17)

Order 2018

North East Lincolnshire Council, hereinafter referred to as "the Council", in exercise of powers under Section 82(2), 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "The Act of 1984"), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:—

1 Title

1.1 This Order shall come into operation on the day of the day of be cited as The Borough of North East Lincolnshire Council (B1203 – East Ravendale to Waltham) (Speed Limits) (No. 18-17) Order 2018

2 Definitions

- 2.1 In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:
 - "The Act of 1984" means The Road Traffic Regulation Act 1984;
 - "Article" means the Article of this Order unless otherwise stated and includes reference to any paragraph to that Article referred to by number or letter;
 - "Council" means North East Lincolnshire Borough Council and includes any parking services contractors or authorised agents appointed by or acting on behalf of the Council for the purposes of any function under the provisions of this Order:
 - "The Plans" means the plans attached to this Order including keys, which has drawing number TR-18-17 assigned to it.
 - "Traffic Regulation Order", "Order" or "TRO" have the same meaning respectively, that being an Order made under powers contained within The Act of 1984;
- 2.2 For the purpose of this Order unless otherwise specified all references to any documents including Statutory Instruments, Regulations and policies and procedures of the Council relate to the current version of those documents as amended or substituted from time to time.
- 2.3 The prohibitions imposed by this Order shall be in addition to and not in derogation of any restriction, prohibition or requirement imposed by any Regulations or Orders made or having effect as if made under The Act of 1984, or by or under any other Enactment.

3 Revocation

From the date this order comes into operation, the provisions of the speed limit Orders listed in Schedule 1 to this order are hereby revoked but only in so far as they apply to the sections of roads listed in column 3 of the tables in Schedule 1 to this order.

4 Speed Limits

- 4.1 No person shall cause or permit any vehicle to be driven at a speed exceeding 20mph on the lengths of road specified in Schedule 2 and as shown indicatively on The Plans to this Order.
- 4.2 No person shall cause or permit any vehicle to be driven at a speed exceeding 30mph on the lengths of road specified in Schedule 3 and as shown indicatively on The Plans to this Order.
- 4.3 No person shall cause or permit any vehicle to be driven at a speed exceeding 50mph on the lengths of road specified in Schedule 4 and as shown indicatively on The Plans to this Order.

Ashby Lane	Ashby cum Fenby	From a point 114 metres west of its junction with Main Road to its junction with Brigsley Road (B1203).
Brigsley Road (B1203)	Ashby cum Fenby	From a point 146m south west of its junction with Ashby lane to a point 40 metres south of its junction with the southern kerbline of Waithe Lane
