NOTICE OF CONCLUSION OF REVIEW

REVIEW OF POLLING DISTRICTS AND POLLING PLACES

North East Lincolnshire Council has concluded a review of polling districts and polling places as required under the Electoral Registration and Administration Act 2013.

At a meeting of Council on 19th September 2019, Elected Members agreed to approve the following changes to the polling districts and polling places in North East Lincolnshire:-

Ward	Change to Polling District
Croft Baker	To merge polling district CB1A with CB1B as polling district CB1.
	To move the nursing home at Lindsey Hall from CB1A into CB2.
	That electors between Davenport Drive and Halton Place (along the Sandringham Road boundary) from CB2 be moved into a new polling district (CB7).
	That electors within those properties on Trinity Road (CB6) be moved into CB4.
	To move electors within properties from Lynton Rise/Thoresby Place to Trinity Road from CB5 into CB6.
Heneage	To move electors in Lea Drive, Haigh Court, Brunel Close and Peaks Lane from HE7 into HE5.
Humberston and New Waltham	That a new polling district is created for the area of New Waltham south of Station Road (incorporating electors from HU4 and HU5). That the polling district be designated as polling district HU6.
	To permit the Returning Officer to split the register alphabetically into two polling districts in the next few years when required.
Immingham	To permit the Returning Officer to split the register alphabetically into two polling districts in the next few years when required
Scartho	To move electors in Bellflower Road, Trefoil Close and Rosemallow Close from SC1 into SC3.
West Marsh	To move electors living at 123 to 141 Boulevard Avenue from WM4 into WM3.
Wolds	To permit the Returning Officer to split the village (WO07) into two polling districts in the next few years when required – either alphabetically or based around a geographical split, whichever is considered acceptable.

Furthermore, Council also agreed to request the Returning Officer to consider using the following polling stations for elections held after May 2020:-

EM4 – Consider using Strand School [as a double polling station]

FR5 – Consider using Cromwell House

CB2 – Consider using Bursar School

CB4 – Consider using St Peter's Church Hall or Trin Youth Centre

CB7 – Consider using St Francis Church Hall

HU5 – Consider using New Waltham Community Pavilion

HU6 – Consider using New Waltham Village Hall

WO2 – Consider using The Ship Inn

All other polling districts and polling places remain unchanged following the review. Full details of the polling arrangements for North East Lincolnshire are available for inspection at the Elections Team, Municipal Offices, Town Hall Square, Grimsby, DN31 1HU and are available at:
