

North East Lincolnshire Borough Council – Traffic Regulation Orders Notice of Making (Various Orders)

Notice is hereby given that on the 05th April 2018 the North East Lincolnshire Borough Council made the below Traffic Regulation Orders under powers contained in the Road Traffic Regulation Act 1984 and the effects of each will be as follows:-

1. The Borough of North East Lincolnshire Council (No Waiting and Loading at Any Time) (Glebe Road, Cleethorpes) (No. 17-12A) Order 2017
 - To introduce 24hr prohibition of waiting restrictions on Glebe Road, Cleethorpes (part).
 - To introduce a 24hr prohibition of loading restrictions on Glebe Road and Bowling Lane, Cleethorpes (part).
2. The Borough of North East Lincolnshire Council (Prohibition of Waiting, and Loading Bay Area) (Cartergate, Grimsby) (No. 17-14) Order 2017
 - To revoke existing prohibition of waiting restrictions on Cartergate, Grimsby (part) and Chantry Lane, Grimsby (part) within the vicinity of its junction with Chantry Lane, Grimsby.
 - To introduce a Loading Only bay 22m in length, on the Eastern kerblines of Cartergate, Grimsby (part) south of the Chantry Lane junction.
 - To introduce 24hr Prohibition of Waiting restrictions on Cartergate, Grimsby (part) within the vicinity of its junction with Chantry Lane, Grimsby.
 - To introduce 24hr Prohibition of Waiting restrictions on Chantry Lane, Grimsby (part) within the vicinity of its junction with Cartergate, Grimsby.
3. The Borough of North East Lincolnshire Council (Prohibition of Waiting Restrictions) (Claymore Close, Cleethorpes) (No. 17-15) Order 2017
 - To introduce 24hr Prohibition of Waiting restrictions along a section of Claymore Close, Cleethorpes (part) which provides sole access from Fairview Avenue, Cleethorpes to the surrounding residential cul-de-sacs.
4. The Borough of North East Lincolnshire Council (Prohibition of Waiting Restrictions) (Caistor Road, Laceby) (No. 17-16) Order 2017
 - To introduce sections of 24hr Prohibition of Waiting restrictions in the vicinity of the turning head at the South Western extent of Caistor Road, Laceby (part).
 - To introduce a section of Prohibition of Waiting Mon-Fri, 8am-6pm at the turning head on Caistor Road, Laceby (part).
5. The Borough of North East Lincolnshire Council (Introduction of Limited Waiting Parking Places) (Abbey Road, Grimsby) (No. 17-19) Order 2017
 - To revoke existing historic Resident Parking Places on a section of Abbey Road, Grimsby (part) between the junctions of Wellowgate and Garden Street.
 - To revoke existing Prohibition of Waiting restrictions (Mon-Sat, 8am-6pm) on a section of Abbey Road, Grimsby (part) between the junctions of Wellowgate and Garden Street.
 - To introduce a 1 hour No Return within 1 hour Limited Waiting Parking Place on a section of the northern kerblines of Abbey Road (part) between the junctions of Wellowgate and Garden Street, which operates Monday-Saturday 8am-6pm.
6. The Borough of North East Lincolnshire Council (Prohibition of Waiting Restrictions) (Campden Crescent, Cleethorpes) (No. 17-28) Order 2017
 - To introduce 24hr Prohibition of Waiting restrictions on Campden Crescent, Cleethorpes (part) within the vicinity of its junctions with Brereton Avenue, Cleethorpes.

- To introduce 24hr Prohibition of Waiting restrictions on Brereton Avenue, Cleethorpes (part) within the vicinity of its junctions with Campden Crescent, Cleethorpes.

These Orders will come into force on Monday 30th April 2018.

If any person wishes to challenge the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Act, or that any requirement of the Act or any instrument made under it has not been complied with, that person may, within 6 weeks from the date on which the Order was made, apply for the purpose to the High Court.
