<b>The purpose we are processing your personal data for is</b>	<p>To provide the following Statutory services: Registration of Births, Deaths, Still Births, Marriages, Civil Partnerships and Citizenship Ceremonies; and Licensing of Approved and Religious Venues (Statutory);</p> <p>To provide the Non-Statutory service for Changing of Name by Statutory Declaration.</p>
<b>Using your personal information for other purposes</b>	<p>We will not process your personal data for any other purpose than that for which it was collected, without first providing you with information on that other purpose and seeking your consent if applicable; except where we are required to disclose your personal data in accordance with legislation, for example, in relation to the prevention and detection of crime, counter terrorism, safeguarding, legal proceedings or to protect interests of you or another.</p>

<b>The fair and lawful basis we are processing your personal data on is</b>	<p><b>Purpose 1 - Statutory activities:</b></p> <p>Article 6 1 c processing is necessary for compliance with a legal obligation to which the controller is subject.</p>

	<p>Article 6 1 b processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.</p> <p>Article 9 2 g processing is necessary for reasons of substantial public interest, on the basis of Union or Member State law which shall be proportionate to the aim pursued, respect the essence of the right to data protection and provide for suitable and specific measures to safeguard the fundamental rights and the interests of the data subject.</p> <p><b>Purpose 2 – Non-statutory activities:</b></p> <p>Article 6 1 b processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.</p>
<p><b>Am I required to provide the Council with my personal data</b></p>	<p>Yes, when you have a statutory duty to register a birth, death, still birth marriage or civil partnerships or when you attend a citizenship ceremony.</p>

<p><b>Can I withdraw my consent for processing</b></p>	<p>No, as we are processing your personal data to comply with statutory obligations.</p>

<b>Transfers of personal data to a third country</b>	Personal data is not routinely transferred outside of the UK.
<b>How long we will retain your personal data for</b>	<p>Permanent for statutory services.</p> <p>10 years for non-statutory services i.e. Change of Name by Statutory Declaration.</p>
