Notice is hereby given that the North East Lincolnshire Borough Council, propose to make a Road Traffic Regulation Order under powers contained in the Road Traffic Regulation Act 1984 the effect of which will be as follows:-

1. To revoke existing prohibition of waiting and loading restrictions on Constitutional Avenue and Imperial Avenue, Cleethorpes.
2. To introduce new prohibition of waiting and loading restriction on Constitutional Avenue and Imperial Avenue, Cleethorpes on match days between 10am and 11pm.

North East Lincolnshire Council, hereinafter referred to as "the Council", in exercise of powers conferred upon it under Sections 1, 2, and 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referenced to as 'the Act 1984'), and of all other enabling powers, hereby make the following Order

1 Recitals

- 1.1 The Council in making this order is seeking to facilitate the passage of emergency services vehicles along the Restricted Roads during match days, to mitigate the risk highlighted to it by the emergency services.

2 Title

- 2.1 This Order shall come into operation on the _____ day of _____, 2017 and may be cited as The Borough of North East Lincolnshire (Prohibition of Waiting and Loading) (Constitutional Avenue and Imperial Avenue) (No. 17-08) Order 2017.

3 Terms and Definitions

In this Order all expressions, except as otherwise herein provided, shall have the meanings assigned to them by the Act of 1984:-

“**Council**” means North East Lincolnshire Borough Council and includes any parking services contractors or authorised agents appointed by or acting on behalf of the Council for the purposes of any function under the provisions of this Order;

“**2004 Act**” means the Traffic Management Act 2004;

“**Civil Enforcement Officer**” means a person employed by, or on behalf of, the Council under the provisions of Part 6 of the 2004 Act and in accordance with Section 76 of the 2004 Act authorised to supervise and enforce the restrictions imposed by this Order and to carry out the functions therein;

“**Restricted Road**” means any of the sides or lengths of roads specified in the Schedules to this Order where waiting is restricted or specific activities are restricted during the restricted hours provided that the expression “restricted road” shall not include any parking place;

“**the Plans**” means the plans attached to this Order indicating the extents of parking restrictions (if any) which are held at the Offices of the Borough of North East Lincolnshire Council;

“**Match Day**” means any day the Grimsby Town Football Club play at Blundell Park. This shall include but is not limited to those games included in the publicised fixtures list, and otherwise advertised by the club.

4 Revocation

- 4.1 The order referred to in Schedule 1 shall be revoked from the date that this Order comes into operation.

5 Prohibition of Waiting and Loading

- 5.1 Save as provided in Article 5.2 no person shall permit any vehicle on Match Days to wait or load between the hours of 10am and 11pm as specified on the Restricted Roads in Schedule 2 as per the Plans to this Order

5.2 Emergencies

Nothing in Article 5.1 shall render it unlawful to cause or permit any vehicle to wait or park in any of the prohibited or Restricted Roads, lengths of road or on

the sides of road or loading areas specified in the Schedules and on the Plans for so long as may be necessary to enable the vehicle to be used in an emergency for fire and rescue, ambulance or police purposes, or in connection with emergency works undertaken by statutory undertakers.

6 **Miscellaneous**

- 6.1** Any reference in this Order to a numbered Article shall, unless the context requires otherwise, be construed as a reference to the Article bearing that number in this Order and any reference to the Schedules or Plans is a reference to the Schedules or Plans incorporated into this Order.
- 6.2** Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 6.3** The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 6.4** The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment.
- 6.5** If a court, the Department of Transport, the Traffic Penalty Tribunal or the Traffic Enforcement Centre declares any part of this Order to be invalid or unenforceable, such declaration shall not invalidate the remainder of the Order.
