THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL
(PHASE 4 – CLEETHORPES REGENERATION ‘ONE WAYS’ – TTRO 20-002A)
(TEMPORARY ONE WAY RESTRICTION OF TRAFFIC) ORDER 2020

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), the Highway Authority for the aforementioned highway in the Borough of North East Lincolnshire, is satisfied that a temporary 'ONE WAY' restriction be imposed to safely facilitate the movement of traffic during the regeneration works taking place in the highway, from Monday 10 February 2020 to Saturday 31 October 2020;

ROAD	Length	Extents
Alexandra Road	PART LENGTH	travelling in a South Easterly direction commencing at the roundabout junction of Sea Road and continuing to a point no more than 15 metres south of Knoll Street junction
Albert Road	FULL LENGTH	travelling in a North Easterly direction commencing at its junction with St Peters Avenue continuing to its junction with Alexandra Road
Yarra Road	PART LENGTH	travelling in a North Easterly direction commencing at its junction with Cambridge Street and continuing to its junction with Oole Road and Library Car Park vehicle entrance.
Knoll Street	PART LENGTH	travelling in a South Westerly direction commencing at its junction with Alexandra Road and continuing to its junction with New Road

NOW THEREFORE the Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all powers them enabling in that behalf hereby make the following Order:

1. A temporary 'One Way' restriction (for the purpose of safely facilitating the movement of traffic during the regeneration works taking place in the highway) along the aforementioned road in Cleethorpes.
2. The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.
3. The Order will come into operation on **Monday 10 February 2020** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.
4. The Order may be cited as "The North East Lincolnshire Borough Council (Phase 4 – Cleethorpes Regeneration 'One Ways' – TTRO 20-002A) (Temporary One Way Restriction Of Traffic) Order 2020".

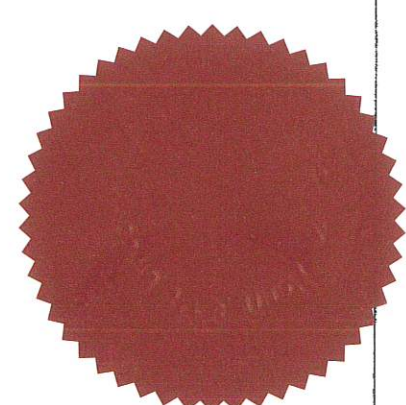
