(TEMPORARY PROHIBITION OF TRAFFIC MANOEUVRE) ORDER 2020

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), the Highway Authority for the aforementioned highway in the Borough of North East Lincolnshire, is satisfied that a temporary '**Prohibition of Manoeuvre**' restriction be imposed in order to maintain traffic flow during the regeneration works taking place in the highway, from Monday 10 February 2020 to Saturday 31 October 2020;

<i>Prohibition of Right Turns</i>	
Alexandra Road	No vehicle will be able to turn right from Alexandra Road on to Yarra Road No vehicle will be able to turn right from Alexandra Road on to Albert Road No vehicle will be able to turn right from Alexandra Road on to Civic Car Park No vehicle will be able to turn right from Alexandra Road on to Knoll Street

<i>Prohibition of Left Turns</i>	
Civic Car Park	No vehicle will be able to turn left from the car park on to Alexandra Road
Yarra Road	No vehicle will be able to turn left from Yarra Road on to Alexandra Road
Albert Road	No vehicle will be able to turn left from Albert Road on to Alexandra Road

NOW THEREFORE the Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all powers them enabling in that behalf hereby make the following Order:

1. A temporary prohibition of manoeuvre' restriction (for the purpose of maintaining traffic flow during the regeneration works taking place in the highway) along the stated roads in Cleethorpes.
2. The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.
3. The Order will come into operation on **Monday 10 February 2020** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

4. The Order may be cited as "The North East Lincolnshire Borough Council (Phase 4 – Cleethorpes Regeneration 'One Ways' – TTRO 20-002B) (Temporary Prohibition Of Traffic Manoeuvre) Order 2020".
