THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL
(SECTIONS OF A18, BARTON STREET, GRIMSBY – TTRO 20-006)
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), the Highway Authority for the aforementioned highway in the Borough of North East Lincolnshire, is satisfied that a temporary prohibition of traffic be imposed to safely facilitate essential maintenance works, the extents of which are:

A18 Barton Street -

Phase 1 – FULL CLOSURES - 13 January 2020 – 24 July 2020

from its junction with Laceby Road 'Oaklands' Roundabout to its junction with Waltham Road –access to Laceby Manor Golf Club and Willows Caravan Site ONLY

Phase 2 – OVERNIGHT CLOSURE – 27 July 2020 – 7 August 2020

from its junction with Waltham Road junction to its junction with B1203 Main Road, Brigsley

Phase 3 – TEMPORARY SIGNALS – 27 July 2020 – 23 October 2020

East Lindsey District Council – between Livesey Road and Salters Lane, Luddborough

Phase 3 – FULL CLOSURE – 4 January 2021 – 28 May 2021

from its junction with C409 road to Beelsby to its junction with B1203 Main Road, Brigsley

Public Bridleway 97, Laceby

Phase 1 – Part Closure

That part of the length of Public Bridleway No. 97 in the Parish of Laceby, which commences at Barton Street (A18) Ordnance Survey grid reference TA 52172 40477 and runs in a generally east north easterly direction for approximately 150 metres to the bridle bridge at Ordnance Survey grid reference TA 52172 40477 to the junction with Laceby Public Bridleway 98.

NOW THEREFORE the Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all powers them enabling in that behalf hereby make the following Order:

1. A temporary road closure (for the purpose of safely facilitating major highway development works) along sections of A18, Barton Street, Grimsby.
2. The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.
3. The Order will come into operation on **Monday 13 January 2020** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.
4. The Order may be cited as "The North East Lincolnshire Borough Council (Sections of A18, Barton Street, Grimsby – TTRO 20-006), (Temporary Prohibition of Traffic), Order 2020".
