1. Subject and details of the matter (to include reasons for the decision)

To seek approval to award the concessions contract for the Sponsorship of Authority Assets following conclusion of the evaluation process.

The provider of the concessions contract will manage the sponsorship programme for the Council's assets.

As this is a Concession Contract the Council will entrust the provider the right to provide the service. Rather than the Council pay the provider for delivery of the service during the concession period, the provider has the benefit of retaining a percentage of the gross income generated from the sale of the sponsorship under this Concessions Contract ("Gross Income") to cover operation of the service and to make a profit. The Gross Income will be shared with the Council in line with the requirements stated in the contract.

The concessions contract will initially run for a period of five (5) years. There is a further possibility of two (2) further twelve (12) month extension periods depending on performance and business requirements.

The estimated whole life value of the contract is £1,381,000.

An open procurement process was followed in line with the Contract Procedure Rules.

Following the completion of the evaluation, Community Partners Limited have been identified as the most economically advantageous tenderer.

Yes. Approval to undertake the procurement was granted by Cabinet on the 28th May 2020.

Cabinet delegated the award approval to the Director of Economy and Growth.
