

**THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL**  
**ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)**  
**A SECTION OF A16 LOUTH ROAD, NEW WALTHAM, GRIMSBY**  
**(TEMPORARY PROHIBITION OF TRAFFIC– TTRO 20-136) ORDER 2020**

**WHEREAS** the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle to proceed along the below sections of highway:

- **OVERNIGHT** - A section of A16 LOUTH ROAD – Part Length from its junction with LOUTH ROAD, HOLTON LE CLAY to its roundabout junction with A1243 LOUTH ROAD and A16 PEAKS PARKWAY.

Alternative route: A1243 LOUTH ROAD, A1243 SCARTH ROAD, A46 LACEBY ROAD, A46 GRIMSBY ROAD, A18 BARTON STREET, A16 LUDBOROUGH BYPASS, A16, A16 LOUTH ROAD  
Or: A16 PEAKS PARKWAY, A1098 HEWITTS AVENUE, A1031 HUMBERSTON ROAD, A1031 CHURCH AVENUE, A1031 HUMBERSTON AVENUE, A1031 TETNEY ROAD, A1031 HUMBERTSON ROAD, TETNEY, A1031 THORESBY ROAD, B1201 FEN LANE, NORTH THORESBY, B1201 STATION ROAD, B1201 HIGH STREET, NORTH THORESBY, A16 LOUTH ROAD.

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by North East Lincolnshire Council. These works are detailed as roundabout and junction development works.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation at **19:00hrs** on **Monday, 16 November 2020** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1), A Section of A16 Louth Road, New Waltham, Grimsby, (Temporary Prohibition Of Traffic – TTRO 20-136), Order 2020"
