Replacement of felt roof system to a large area of the school. This is to be replaced with an icopal roof system. The roof scheme is on a rolling programme of prioritisation agreed between ENGIE surveyors and the NELC school assets team to replace the existing roof which is past its lifetime and suffers ponding and leaks.

Due to impact of covid19 upon the building trade and ability to secure materials we have had a few schemes that we have had to put back into the programme or consider at a later date. This scheme included for an extra area in need of repair which was dependent on work capacity and indicated works at other school sites. Due to other works have not progressed this additional elevation can be brought forward into the 20/21 programme and included in the scheme rather than having to go to tender and pay extra prelims to undertake the elevation next year.

Instead of calling off from the Technical Design Services Framework for capital works, this scheme has been tendered to x5 approved ENGIE/NELC roofing contractors to ensure value for money and no extra principal contractor cost should we have gone through the framework to building contractors.

This work has been viewed by the contractors in the contract report who have both been on the roof and priced the works. Engie are happy with the price and believe the tender report shows how competitive the pricing is. With works totalling £127,872.18 excluding fees is the most competitive tender.
