Approval is sought to award a contract for the Humberston Fitties Erosion Mitigation Study. A consultancy contract has been tendered through YorTender, and there have been several bids returned. The quality and pricing assessment has been completed and we are now ready to award the contract to the winning tenderer.

The study will identify the causes of the erosion at the Humberston Fitties and identify an appropriate scheme to prevent both erosion and flooding. The scheme will also aim to re-establish a healthy beach at the Fitties. This information will be used to produce a business case to the Environment Agency to secure funding through Flood Defence Grant in Aid, leading to the construction of the new defence/mitigation measures. A Council business case will also be produced, supporting any proposals for investment.

- 1. To authorise the Director of Economy and Growth, in consultation with the Portfolio Holder for Environment and Transport to commence a procurement exercise and ultimately award for consultancy support in connection with the Humberston Fitties Erosion Mitigation Study.
- 2. Thereafter (subject to internal governance procedures (Business development etc)) to produce a business case to the Environment Agency to secure funding

through Flood Defence Grant in Aid, leading to the construction of new defence/ mitigation measures.

To proceed with the award for award of Humberston Fitties Erosion Mitigation Study.

The contract award process will be managed through YorTender, with assistance from the (Engie) Procurement team. YorTender is the procurement portal for local authorities in the Yorkshire and Humber region.

Other options considered with regards to the Humberston Fitties;

Do Nothing- The current erosion trends would see continued significant sand loss and collapse of the defences within an estimated 3 - 5 years, weather conditions permitting.

Do Minimum – Use of maintenance budgets to try and delay the worst of the erosion, likely to only prolong the life of the defences by 5 years at the most and this is not sustainable.
