Officer Decision Record

1. Subject and details of the matter (to include reasons for the decision)

This ODR is to record decisions in relation to the Garth Lane Waterfront Improvement Scheme including the footbridge colour scheme, a new location for the Fishing Heritage Centre sign, arrangements for the ABP pump station compound, artistic paving details and street furniture, in accordance Cabinet decision DN.70 dated 18th December 2019. All items included within this ODR form part of the C R Reynolds Contract who are currently contracted and are on site delivering the project.

2. Is it a Key Decision as defined in the Constitution?

No. Cabinet delegated authority to take all actions necessary to secure the continued implementation and ultimate completion of the scheme including detailed design changes, including bridge design, planning applications and all ancillary issues arising, to the Interim Director of Economy and Growth in conjunction with the Leader of the Council.

3. Details of Decision

For the Executive Director for Environment, Economy and Resources to approve design details for the Garth Lane Waterfront scheme, following Officer consultation with the Leader on 16th December 2020 as follows: -

Footbridge Colour scheme

Early discussions with the Leader, Portfolio Holders for Regeneration, Skills and Housing; Environment and Transport; and Tourism Heritage and Culture resulted in a desire for a blue bridge deck and a colour scheme which represents the fishing industry and a trawler. Further consultation with the Leader has led to a preference to combine a blue bridge deck with ochre masts and white rails (RAL numbers 5013 Cobalt Blue, 1024 Ochre Yellow, 9003 Signal White - image included in Appendix 1).

New Location for the Fishing Heritage Sign

The FHC sign has been removed and refurbished, it will be repainted to match the mast structure of the bridge and a new position has been agreed adjacent to the

footpath west of the ABP compound (location plan Included in Appendix 1). The planning permission for the relocation of the sign will be submitted once this ODR has been approved.

ABP Compound

ABP are due to undertake improvement works within the pump station compound consisting of upgrading the ramp access and walls / internal balustrade, security door and window upgrades, fascia upgrades and surfacing upgrades.

As ABP has agreed to undertake the improvement works above, which will benefit the scheme and improve the overall appearance of the area, the Garth Lane Waterfront Improvement scheme will fund the replacement of the compound security fence which has an ISPS Security Level requirement. Fence types of this nature are very limited; however, the new fence will be a visual improvement on the existing palisade fence and will provide better screening (image included in Appendix 1).

Artistic Paving

Developed by Our Big Picture through the 'Our Haven' public art project, a wind turbine inspired motif is proposed to be inset into the paving, constructed from a combination of traditional tegula and grey conservation blocks, offset by silver grey channel blocks. Three 1m diameter bespoke stone focal features based on the Grimsby seal will be developed through the 'Our Haven' project (image included on Appendix 1). A decision on the realignment of the footpath is due to be heard at planning committee early 2021.

Street Furniture

Railings, to assist access down to the steps, have been chosen and are included on Appendix 1. It was agreed that benches and bins will be procured to match the new street furniture on Riverhead as and when this is agreed.

Bridge Colour scheme

A black/ochre/white option was presented as an alternative option; however, the blue option was the preferred colour scheme to be taken forward.

New Location for the Fishing Heritage Sign

Four possible locations were presented, the preferred option was chosen as it is a more prominent location.

ABP Compound

The fence specification is an ABP requirement.

Street Furniture

Two options for balustrades were presented. The preferred option was selected as it was felt that the design was more modern and complimentary to the bridge design. The preferred option could also be extended to other areas of the waterfront at a later date, if funding becomes available.



Proposed new location is shown opposite.


