PROHIBITION NOTICE

To: Mr Lee Collins

This Prohibition Notice is served under regulation 9(2) of The Health Protection (Coronavirus, Restrictions) (All Tiers) (England) Regulations 2020 ("the Regulations") and has immediate effect.

The Regulations impose certain restrictions to protect against the risks to public health arising from coronavirus. Fallure to comply with the requirements of the Regulations, without reasonable excuse, is a criminal offence.

I, Adrian Watson Moody, designated as a relevant person for the purposes of the Regulations by North East Lincolnshire Borough Council, have reasonable grounds for believing that you are contravening a requirement in the Regulations as set out in Part B below and that it is necessary and proportionate to issue this Prohibition Notice to prevent you from continuing to contravene that requirement.

Part B. Contravention of the restrictions

Regulation contravened: Lee Collins on the 13 February 2021 carried on a business/provided a service other than as permitted by the exceptions listed in paragraphs 12 and 13 namely: a public house and being in contravention of regulation 8, and Part 3 of Schedule 3A, paragraph 11(1), to The Health Protection (Coronavirus, Restrictions) (All Tiers) (England) Regulations 2020

Particulars of the offence: Humberside Police Officers attended the premises at about 2230 hrs on Saturday 13th February 2021 following complaints. On their arrival about 20 persons ran away as they entered. One person was apprehended and he claimed to the Police Officers that the Designated Premises Supervisor had told him to open the premises so people could drink.

Part C. Action required

This Prohibition Notice requires that you immediately cease the activities identified in Part B giving rise to contravention of the Regulations. The measures specified below must be taken to prevent continued contravention of the Regulations:

Cease carrying on a business/providing the service of alcohol other than as permitted by the exceptions listed in paragraphs 12 and 13

Part D. Consequences of non-compliance with this Notice, and with the Regulations

Failure to comply with this Prohibition Notice, without reasonable excuse, is an offence under regulation 10 of the Regulations, punishable by a fine on summary conviction in a Magistrates' Court.

A fixed penalty hotice may be issued in accordance with regulation 11 and 12 of the Regulations, or you may be prosecuted under regulations 10 and 13 of the Regulations.

Part E. Challenging this Prohibition Notice

If you consider that the Notice should not have been issued, you can make representations to North East Lincolnshire Borough Council in writing outlining your reasons for challenging the Notice, within 7 days of the date on this Notice.

I wish to draw your attention to the attached email from that was sent to Mr Collins on 18 February 2021 which confirms that Mr Collins was not aware of the incident, and therefore Mr Collins did not carry on a business or provide a service as stated in the notice. The email confirms that Mr Collins, the named DPS, did not tell to open.
I would like to point out that a prohibition notice cannot be issued to prevent a business operating that is already prohibited from operation due to other regulations. A prohibition notice must seek for measures to be put in place before opening. That is not possible in this instance.
For the above the prohibition is wrong and we therefore request that it be withdrawn.


