The Prevention of Crime and Disorder	
Public Safety	This representation is made in support of the licence review of Mariners Rest, Albert Street East, Grimsby, DN32 7DN. From a public health perspective, we are very concerned about this premise as they are reported to have acted irresponsibly by continuing to open despite the provisions of COVID-19 legislation. Indoor settings such as public houses are one of the highest risk locations for the spread of COVID-19 and we have identified outbreaks associated with these settings in the last six months. Coronavirus lockdown legislation has specifically identified that public houses must not open during lockdown periods due to these risks and the vast majority of such businesses are believed to have complied which has helped ensure that our COVID-19 rates have not escalated during the difficult winter period. By opening the business and allowing people from multiple households to access the premises they have put the health of these individuals at risk, they have increased the risk to the health of the community by potentially spreading the disease into other community settings and they have attempted to profit from the challenging economic situation when other businesses have acted in a more community responsible way.
