Humberside Police seek a review of the Premises licence due to repeated breaches of Coronavirus Legislation and guidance since the DPS has been in charge of the premises, which was August 2020.				
By breaching the restrictions put in place by the government is likely to put members of the public at risk due to the ongoing pandemic, undermining the Public Safety Licensing Objective, and by breaching the legislation put in place is undermining the Crime and Disorder Licensing Objective.

The UK, like most other countries around the World, has fallen victim to the Pandemic Disease, Covid-19. In the UK, the Government has introduced various Regulations since March 2020 in an effort to stop the spread of the virus, reduce the number of deaths and stop infection rates. Some of these regulations have resulted in financial and economic hardship for many sectors across the country, but the Government has deemed the measures were necessary in an effort to fight the virus.

This application for a review of the Premises Licence relates to Mariners Rest, Albert Street East, Grimsby, due to a number of Covid breaches since the DPS took over the premises in August 2020.

On 18th September 2020, a joint visit between Humberside Police Licensing and North East Lincolnshire Council Licensing department due to noise issues at the premises. Due to COVID-19 restrictions, there were volume restrictions for entertainment, as well as restrictions for dancing, singing, standing at the bar (table service only). The premises was found to have loud music playing from the premises, which could clearly be heard outside the premises. Patrons were seen dancing and music being played was encouraging dancing. This was a week before the guidance was made law, and a warning letter was issued.

A further breach was reported to Council Covid Officers, who stated a wake had been held at the premises on 21st October 2020, with a finger buffet served, no persons sat at the tables and no face coverings being worn. A further joint visit was made on 23rd October 2020 to speak to the DPS to discuss the breach. The DPS stated there had been around 40 people in the premises for the wake, which was a breach of the guidelines for the Tier we were in, which was limited to 15 people, and also breaching the requirement for Table Service for any food and drink consumed on the premises. A second, final warning letter was issued after this meeting.

It was requested to the DPS and the PLH that a Minor variation be submitted to update the licence, so it is fit for all parties, but this has not yet been received. It has been said that the Licence holders were looking at transferring the licence to the DPS. No application has been received.

On 13th February 2021, 3 calls were received to the police to report people in the premises when it should be closed. At one point it was reported that there were 20+ people in there. This was confirmed by police, who on attendance found a number of people fleeing the premises. This was during a nationwide lockdown that had been implemented on 6th January 2021, where all hospitality venues were required to be closed by law until further notice. A Covid fine was issued to the person who opened the premises.

There is clearly an ongoing disregard to the ongoing pandemic, with a lack of compliance to the Coronavirus Health Protection Regulations 2020 by the DPS.
