

**The Borough of North East Lincolnshire (Prohibition and Restriction of Waiting, Clearways and On Street Parking) (Consolidation) (Amendment No. 1) Order 2010.**

The Borough of North East Lincolnshire in exercise of the powers under Sections 1(1) and (2), 2(1) to (3), 3(2), 4(1) to (3), 32, 33, 35, 37, 38(1), 45, 46, 46A, 49, 51, 53, 63A, 65, 68, 69, 71, 101, 102 and 116, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and having regard to Section 122 of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and the Traffic Management Act 2004 hereby make the following Order:

1. The Borough of North East Lincolnshire (Prohibition and Restriction of Waiting, Clearways and On Street Parking) (Consolidation) Order 2010 shall be amended by the revocation of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedules specified in the Second Schedule to this Order.

2. The effect of the Order will be to: -

(a) Introduce a prohibition of waiting in the following locations:

lengths of roads within Cleethorpes

Chichester Road, Coronation Road, Grimsby Road, Riverside Drive, Wesley Crescent;

lengths of roads within Grimsby

Allenby Avenue, Beeson Street, Central Parade, Cromwell Road, Douglas Avenue, Fairfield Road, Ferriby Lane, Fildes Street, Genesis Way, Grange Walk, Homefield Avenue, Innovation Way, Lancing Way, Lakeside, Littlefield Lane Louth Road, Mendip Avenue, New Cartergate, Pasture Street, Pegasus Way, Peryton Way, Rookery Avenue, St. James Avenue, St. Leonard's Avenue, Scartho Road, Somersby Street, Sorrell Road, Southwold Crescent, Springfield Road, Waltham Road, Westkirke Avenue, Wicklow Avenue, and un-named roads on the Europarc Estate;

lengths of roads within Humberston

Midfield Road;

lengths of roads within Immingham

Alderney Way, Hollingsworth Avenue, Manby Road, Margaret Street;

lengths of roads within New Waltham

Anningson Lane, Peaks Avenue;

lengths of roads within Waltham

Brian Avenue, Barnoldby Road.

(b) Introduce waiting restrictions in the following locations:

lengths of roads within Grimsby

Abbey Park Road, Bargate Avenue, College Street, Strand Street, Welholme Avenue;

lengths of roads within Great Coates

Meadowbank.

(c) Revoke waiting restrictions in the following locations:

lengths of roads within Cleethorpes

Brereton Avenue, Fairway Court, North Sea Lane, Riverside Drive,  
Seaford Road;  
lengths of roads within Grimsby  
Convamore Road, Hainton Avenue, Kent Street.

(d) Introduce limited waiting facilities in the following locations:  
lengths of roads within Grimsby  
Albert Street West, Freeman Street, Garibaldi Street, Nelson Street.

(e) Introduce loading only restrictions in the following locations:  
lengths of roads within Grimsby  
Garth Lane, Kent Street.

(f) Introduce prohibition of loading in the following locations:  
lengths of roads within Grimsby  
New Street, Town Hall Square.

These restrictions will replace any existing restrictions currently in force.

3. This Order shall come into operation on 12<sup>th</sup> September 2010 and may be cited as The Borough of North East Lincolnshire (Prohibition and Restriction of Waiting, Clearways and On Street Parking) (Consolidation) Order 2010 (Amendment No. 1) Order 2010.
