Approval is sought to award the contract for the Local Taxation and Benefits Printing and Postage Service.

The supplier of the contract will provide a secure off-site printing and postage service to the Local Taxation and Benefits Service.

Cabinet approved the commencement of the procurement on the 30th September 2020 and the delegation of the award decision to the Director of Resources and Governance, in consultation with the Portfolio Holder for Finance and Resources (DN.39).

A further competition was run under the Crown Commercial Service Postal Goods, Services and Solutions Framework (RM6017) – Lot 7 Hybrid Mail, Digital and Transformational Communications.

An exception to the Contract Procedure Rules to access the framework was approved.

The initial period shall be forty-eight (48) months from the Call-Off Start Date, with the option to extend for a further two (2) further twelve (12) month periods depending on performance.

The estimated whole life value of the contract is £968,579.60. The contract will also be accessed by North Lincolnshire Council, so this value contains their spend as well.

Following the completion of the evaluation process, Capita Business Services Limited have been identified as the Most Economically Advantageous Tenderer.
