Purchase of Sweepers

The Council is seeking approval to award contracts for the purchase of the following types of sweeper:

Three 4.5 tonne to 5 tonne GVW compact sweepers.

Two 15 tonne truck mounted road sweepers.

The total value of the purchase is £483,281.61.

The opportunity was split into two lots:

Lot 1 three 4.5 tonne to 5 tonne GVW compact sweepers.

Lot 2 two 15 tonne truck mounted road sweepers.

Cabinet approval to undertake the procurement and delegate the award decision was received on the 13th January 2021 (DN.78)

An exception to run a further competition under the YPO Specialist Vehicles Framework (960) Lot 3 Purchase of Sweepers was approved on the 10th February 2021.

Following completion of the evaluation process, Scarab Sweepers Ltd (Lot 1) and Bucher Municipal (Lot 2) have been identified as the Most Economically Advantageous Tender.
