The bridleway where the ash tree sits is unregistered, therefore whilst it is possible the Lincoln Diocesan Trust and Board of Finance Limited owns this tree given that they own the immediate surrounding area, cannot be 100% sure whether the tree is owned by them or whether the tree is the Councils responsibility. Query raised with the Council but ownership of this area has not been determined. Have selected that the client owns the tree in the application but this note better reflects the actual position. 1 x Large Hawthorn - Fallen tree laid on field margin. Just clearing off site. (Assume that no TPO application is required but included just in case as works will be undertaken simultaneously).
