CONTRIBUTION TO OUR AIMS

A borough wide Parking Strategy directly supports both the Council's priorities of a "stronger local economy" and "stronger communities" by ensuring that there is an effective and equitable approach to both on and off-street parking.

The Council has clear ambitions for the economic growth of North East Lincolnshire as set out in its Economic Strategy and Local Plan. Sustainable transport is integral to this, and the use of private vehicles is one option, which is part of the transport mix.

This report and the appended documents present an approach to the policy and provision for the Council's pay and display car parks, that aims to meet the needs of businesses, residents, and visitors to the borough.

EXECUTIVE SUMMARY

The purpose of this report is to seek approval to proceed with "a Notice of Variation" and exercise its powers under section 35C of the 1984 Act to increase the tariffs in Cleethorpes. Once these changes are in place, to follow with consultation in accordance with statutory requirements and proceed with the making of the proposed Off-Street Parking Places Order 2022, if no objections are received.

A number of additions and changes to the current off-street parking order, in respect of various aspects of parking provision across the borough are required to enable effective operational management and enforcement of council car parks. Approval is sought to revoke the 2012 Order and subsequent amendments and authorisation to proceed with making a new Parking Places Order in accordance with statutory requirements.

This report captures the updates to a proposed new Order 'The Borough of North East Lincolnshire Council (Off-Street Parking Places) Order 2022'.

Full details of the changes to be included in the Notice of Variation to the current 2012 Order and the subsequent proposed new 'The Borough of North East Lincolnshire Council (Off-Street Parking Places) Order 2022' are scheduled in Appendix 1 to 5.

Appendix 1 – Lists Parking Place locations, which are either being removed from the North East Lincolnshire Borough Council (Off-Street Parking Places) Order 2012 and any subsequent amendment Orders, or they are to be relisted with a new title.

Appendix 2 – Details any changes to current parking provisions.

Appendix 3 – Details amendments of charges for Parking Season Tickets and Business Parking Permits.

Appendix 4 – Details the review of parking provision and Season Tickets.

Appendix 5 – Details the proposed increases to existing car parking charges.

RECOMMENDATIONS

It is recommended that the Portfolio Holder

- 1. Approves the publication of a Notice of Variation pursuant to Section 35C of the Road Traffic Regulation Act 1984 and Regulation 25 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 of a proposal to vary parking charges identified in The Borough of North East Lincolnshire Council (Off-Street Parking Places) Order 2012' (as amended).
- 2. Approves the commencement of 'The Borough of North East Lincolnshire Council (Off-Street Parking Places) Order 2022' for consultation in accordance with statutory requirements. Exercising its powers under Sections 32, 35, and Part IV of Schedule 9 to the Road Traffic Act 1984 (as amended) ("the Act") and of all other enabling power and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.
- 3. Subject to no objections being received, the Portfolio Holder approves the making of the Parking Places Order, as detailed in attached appendices.
- 4. In the event that there are unresolved objections to the Order, these are referred back to the Portfolio Holder for determination and decision as to whether or not the Parking Places Order be confirmed.

REASONS FOR DECISION

An up-to-date Parking Strategy is an integral part of the Council's wider strategic framework supporting the ambitions detailed in its adopted Local Plan and Economic Strategy.

1. BACKGROUND AND ISSUES

- 1.1 North East Lincolnshire was designated a civil enforcement area for parking contraventions in 2010. The current Parking Order was approved in 2012. Since that time there have been a number of operational changes that need to be included in the Order. It is considered that there are a significant number of changes that would require a new Order.
- 1.2 A review of parking provision across the borough, together with the management of parking permits is timely and in the best interests of the Council in ensuring an economical and sustainable approach to these matters.
- 1.3 Further, with the delisting of some areas previously included in various parking orders and schemes, a rationalisation exercise is prudent. It is proposed that such rationalisation be captured in "The Borough of North East Lincolnshire Council (Off-Street Parking Places) Order 2022" subject to due process through the Portfolio Holder for Environment and Transport.
- 1.4 Parking tariffs have not increased since 2012.
- 1.5 The decision to increase income from car parking charges is intended to secure the long-term funding required to cover the cost of maintaining the parking assets, which in turn will impact upon the visitor economy for the borough.
- 1.6 The attached appendices underpin such a review and demonstrates Cabinet oversight.

2. RISKS AND OPPORTUNITIES

- 2.1 A Notice of Variation allows for changes to tariffs without objections. The increased charges are part of the 2022/23 budget setting process. If failures are identified in how these charges are being applied, or they are not applied in a timely manner, the Council is at risk of not recovering sufficient funds to deliver its car parking strategy.
- 2.2 The proposed parking restrictions can be enforced under the Council's Civil Parking Enforcement (CPE) powers.
- 2.3. The legal process involved in making Orders requires that a formal consultation process be undertaken to allow stakeholders to express their views towards the proposal. Should the correct procedures for formal consultation not be adhered to, those consulted upon may have the right of appeal through application to the High Court.
- 2.4. The recommendations of this report will allow the councils car parks to support other council strategies, including Carbon Roadmap, Bus Service Improvement Plan, Town Centre, and Resort Masterplans, and 2018 adopted Local Plan.
- 2.5. Any increase in prices could lead to increased displacement of vehicles into neighbouring streets. It is suggested that the variation of the tariff proposed within the report is achieving harmonisation with other similar locations by

setting a fair price in respect of parking demand and supply. It is not anticipated that the variation proposed will have a significant impact on displacement because the price is considered to still be fair and reasonable, and the same volume of parking bays remains available.

3. OTHER OPTIONS CONSIDERED

- 3.1. Do nothing The opportunity to review the Parking Strategy and realign to the current economic regeneration of the borough would not be realised and this would be a lost opportunity.
- 3.2. Take forward Cabinet approved recommendations from December 2018 only.

4. REPUTATION AND COMMUNICATIONS CONSIDERATIONS

- 4.1. To enact certain aspects of the review orders will be formally advertised in accordance with legislation. Public notices will be published in the local press and erected in the relevant Off-Street Parking Places to give advice on the Council's intention to make any order. This provides an opportunity for anyone to engage with the making of the order. Process is designed to ensure transparency for the approval and subsequent publication of the Borough of North East Lincolnshire Council (Off-Street Parking Places) Order 2022.
- 4.2. Communication regarding the progress and delivery of any order will be through:
 - Publication of the relevant public notices in the local press and in all relevant parking places
 - Portfolio Holder updates
 - Email to Ward Councillors and Town/Parish Councils on commencement of each stage of the process
- 4.3. There is a potential negative reputational risk for the Council if objections to a Traffic Regulation Order (TRO) are received where a resolution is not possible. Should this occur the Portfolio Holder will resolve.
- 4.4. There are potential positive reputational implications for the Council resulting from the decision, to phase out business permits at £102.13 a year and replace with the option of a Single Use Season Ticket at £450.00 a year. This is being mitigated by a phased increase for existing customers over two years.
- 4.5. It is expected that there may be a potential risk of negative reputational implications for the Council, resulting from the decision to increase tariffs In Cleethorpes.
- 4.6. Once approval has been given the timescale for implementation is expected to be approximately between six to eight weeks. This will be dependent on the lead times for new ticket machine software and the acquisition of new tariff boards. This is also dependent on the resolution of any objections to the making of the order.

5. FINANCIAL CONSIDERATIONS

- 5.1. The recommendation will require a financial contribution to cover the costs of new notice boards. The cost is currently being confirmed and is expected to be in the region of £45,000, which is proposed to be funded from the additional revenue which will be generated.
- 5.2. The cost of advertising any new order and any associated costs for software changes and repair and maintenance of the existing notice boards are covered through the Council's Regeneration Partnership arrangement with EQUANS.
- 5.3. The proposal delivers improved value for money by including additional eligible car parks in a General Use Season Ticket and new options to purchase Season Tickets for a single car park will be available.
- 5.4. Based on a financial projection for current ticket sales, car park revenue for a whole year could increase by £350,000, dependant on parking trends.

6. CHILDREN AND YOUNG PEOPLE IMPLICATIONS

The proposals have limited implications for children and young people but deliver improvements to road safety by encouraging vehicle road users to utilise properly designated off road parking facilities.

7. CLIMATE CHANGE AND ENVIRONMENTAL IMPLICATIONS

- 7.1. The proposals are not expected to significantly impact on climate change.
- 7.2. The introduction of a four-hour limit in the EV charging bays will allow for turnover of the current EV spaces and in any further introduction of new Electric Vehicle Charging Points (EVCPs) in line with the carbon road map. Helping to make the resort a sustainable travel destination.

8. CONSULTATION WITH SCRUTINY

There has been consultation with the Economy Scrutiny Panel (4 January 2022 and the 1 March 2022) on the Car Parking Strategy, ahead of the report being approved by Cabinet on the 9 March 22.

9. FINANCIAL IMPLICATIONS

As outlined in section 5, the changes proposed are estimated to generate additional income in support of the Council's Medium Term Financial Plan in delivering the Car Parking Strategy.

10. LEGAL IMPLICATIONS

- 10.1. Under Section 35C Traffic Regulation Act 1984 traffic authorities are empowered to vary charges for off street parking. Under section 32 and 35 traffic authorities are entitled to make off street parking orders.
- 10.2. The procedure to be followed before varying charges to off street parking orders is set out in regulation 25 of the Local Authorities' Traffic Orders

(Procedure) (England and Wales) Regulations 1996.

- 10.3. The procedure for making orders is set out in Schedule 9 Part III of the 1984 Act and the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and provides for advertisement and consideration of any objections before making a final decision on the proposed Order.
- 10.4 Regulation 8 makes provision for objections and regulation 14 allows the Council to modify an Order before it is made.

11. HUMAN RESOURCES IMPLICATIONS

There are no direct HR implications.

12. WARD IMPLICATIONS

The proposals affect all Wards within the Borough.

Appendix 4

Review of Parking Provision and Season Tickets.

- 1. Introduce a four-hour maximum stay on the Leisure Centre car park, Cleethorpes.
- 2. Phase out business permits in Cleethorpes at £102.13 a year and replace with Single Use Season Tickets as set out below. Increase the cost of reserved parking bays on the Fishing Heritage car park, currently at £300.
- 3. Revised range of Season Tickets as set out in the Appendix 3. This includes the addition of eligible car parks to a general season ticket with an increase to £670, the creation of a single use season ticket and savers season ticket options at a cost £450 and £250 respectively

First year £225
Second year £450
New customers £450

Reserved bays £450 from the next annual renewal

- 4. The inclusion of four reserved visitor parking bays to Civic Offices forecourt, with an allowance of two hours free stay. These bays would not be available for council staff who hold staff parking permits. Enforcement of the forecourt to be brought into scope with 'staff permit' holders, enforceable Monday to Friday.
- 5. Introduction of a maximum four-hour stays, for vehicles parked within Electric Vehicle (EV) only parking bays.
- 6. Introduction of 'Cashless' parking as an additional option for payment (pay by phone or mobile application).
- 7. Introduction into legal order to support marked reserved bays, this includes:
 - Police Bays Civic Offices car park
 - Coroner's Bay Cleethorpes Town Hall
 - RNLI Bays Central Promenade
 - Coach Bay Heritage Square
 - Visitor Bays Civic Office Forecourt
- 8. Amendments to operational hours are presently necessary for the following car parks.
 - Thrunscoe Land Partial overnight closures
 - Market Hall Roof Closed on a Sunday, except by notice
 - Abbey Walk Amendment to opening hours

- 9. Inclusion into the legal order to allow reactive introduction of free periods of parking. This would only be enacted with Portfolio Holder Environment and Transport approval, and statutory 21-day notification period.
- 10. Recommended that further consultation and development is required on the following items.
 - Marine Walk car park consult on the potential introduction of maximum stay and overnight access restrictions
 - Two-hour free parking restrictions on Church Lane car park, Humberston
 - Two-hour free parking restrictions on Waltham Road car park, Scartho, as above
 - A review of HGV parking strategy and charging
 - A review of motorcycle parking
- 11. Consultation carried out in 2020 on the following items did not secure sufficient support and as such will not proceed, whilst some items require further investigation, as referred to in point 10 of this appendix.
 - Introduce a seasonal charge of £1.50 on Marine Walk car park
 - Introduction of a four-hour maximum stay parking restriction at Church Lane car park, Humberston and Waltham Road car park, Scartho
 - Removal of a one month and six-month Season Ticket options
 - Reduce parking options for Season tickets holders. Cartergate car park will remain as an available parking option, and parking within Abbey Walk car park will not be limited to the upper levels.
 - Maximum stay of four hours on the following car parks; St Peters
 Avenue, Wardall Street, Market Hall Roof and Cartergate. All day
 parking will be retained on these car parks.
