Change of use of dwelling to a residential care home for up to 5 young people, 184 Waltham Road Grimsby North East Lincolnshire DN33 2PZ

Representation to the Planning Committee from Richard Appleton on behalf of the Residents of the Waltham Road/Southfield Road and Immediate Area.

Thank you for this opportunity to speak to the Planning Committee today...

The Proposal's Architects will hereon be refered to as 'EMERY' or 'KEYS'.

Some have said that the outcome of this application is pre-determined, and that these speeches are a waste of time... Well, this is a 'Cross-Party' Committee - allegedly with the safety and wellbeing*(1) of the people it represents at it's heart. So PLEASE don't let Politics influence your decision. You say you are a 'Listening Council' - Please listen to the voice of the people in the immediate vicinty of 184 Waltham Road.

85 close-by Residents were canvassed ... NOT ONE PERSON was of the opinion that it would be good for the neighbourhood.

WE STRONGLY OBJECT TO THE PROPOSAL.*(2) ... agreed, it would be good thing for these people with their Drugs and Sexual and Behavioural and other 'Social Issues', but we maintain that it is wrong for the area... for many reasons.

The Council's LOCAL PLAN is not just about Bricks and Mortar. It's LOCAL POLICY states that 'Planning Application decisions can be based on', amongst other things, 'HIGHWAY SAFETY, LOCAL AMENITY, NOISE and PRIVACY'.

'A REFUSAL may be agreed even though the principle of the development is acceptable'.

The Local Plan, actually states that 'the Council will support the provision of housing that maximises independance and choice for older people with specific needs (especially) when assessing the suitability of sites and/or proposals for the development of residential care homes'... etc... That is what we already have! These needs are already well supported - by this Council! Dropping this bombshell in the middle of the Community would mentally (and probably physically in time) devastate those in the immediate area... Many have already said that they would sell up and leave should this application be accepted ... thus ripping the well-established heart out of the area.

Highways Safety:

... states 'Approval - on the information provided'. Exactly how much information was provided re Access, Capacity, Safety and Parking? and where from? Google Earth? ... Was a site visit done? Stills*(3) from a 57 second-long video (available on Youtube), filmed at a non-peak time of day, show 5 dangerous near-misses ...and that's with ONLY ONE car parked outside.

Emery/Keys would have us believe in their patronising statement that there would be no problems - up to 6 cars can park in the grounds of 184 and turn in their own circle within those confines!

NONSENSE - Do a site Visit! Go and see for yourselves! As many as 10 or more Carers/Staff/Ancilliaries and Relative's vehicles could be parked along the highway at any one time.... very Dangerous - as well as being a prime target for the house's Residents - or any 'associates' who might be lurking outside - day or night!

Noise & Privacy:

Local Amenity already covered... So Noise and Privacy ... 184 could house five 'very Socially Challenged' 18 year olds... with a huge garden in which to amuse themselves! There are no 'youthful' amenities for them! THERE WILL BE NOISE! ... which will disturb the PRIVACY of all neighbouring Residents - the Council Tax Payers who elected you Committee Members to work for them!

The Building may be deemed secure ...not so the grounds, which are easily exited, over walls and through the large holes in the ancient hedges*(4)

Indeed, Councillor John Briggs from North Lincs Council told me 'Yes- they do get out - they will get out', stating that 'from a Keys establishment in Eastoft we had them running riot up and down the street'!

Policing:

The Police, rightly so, are ambivilent at present. Marc Dias - Crime Reduction Officer, states 'No Objections', but Scartho's P.C. Skelton and PCSO Leaning state that they, and Humberside Police, would monitor the situation very closely. That would mean that 184 would be definitely taking up valuable resources of an already overstretched local Police Force that could be better used elsewhere.

Health and Safety:

I refer you to the Council's own Safeguarding Policy Statements for Vulnerable Adults and Vulnerable Young Children...

To even consider placing people with all sorts of Abuses, Drugs and Sexual and Behavioural Problems right next door to 4 Homes containing vulnerable people*(5) is nothing short of madness!

Then there is also the Mental Health of all of the elderly residents around the area to consider...

Please consider it... They are frightened.

In Conclusion:

I could highlight many more inadequacies of the Keys Group operation*(6)... please see the information provided...

One Councillor stated last week that 'we don't really know anything about them' ... so here's some easily 'check-upable' FACTS...

20% of Keys operations Ofsteded last year were unable to attain even 'Good' level.

Keys Group get £187,000 per year for each resident ... £953,000 per year all told! and who pays them this ... the Local Council ... i.e The Council Tax payer!

At the end of the day Keys Group are only concerned with MONEY!

... and if you Members of the Committee accept this propsal it will cost us all much more than

money...

YOU will have a Community living in Constant Fear, with all of the consequences that that will bring. Do you really want to be party to that?

PLEASE refuse this application.

BuzzFeed News interviewed dozens of former Keys staff, childcare professionals, social workers, and local police forces; analysed hundreds of government inspection reports; and obtained a leaked cache of over 800 internal company documents as well as police records, forensic reports, and the damning confidential "serious case review" conducted by local authorities to determine whether Aaron Leafe's death could have been prevented.

Our investigation has found:

Under pressure to fill homes and meet profit goals, Keys management continued to place vulnerable children in the same homes as violent peers — with "traumatic" results.

Children in Keys homes have been sexually abused, physically assaulted, recruited into gangs, and allowed to self-harm. In just a three-month span in 2016, there were 15 reports of possible child sexual exploitation among the 230 children in Keys homes.

Councils continued to pay Keys vast sums: up to £400,000 per year for the care of a single child. That's almost 10 times the cost of sending a child to Eton College. Yet Keys homes and staff remained starved of resources.

Overburdened Keys employees allowed children to go missing thousands of times in a single year, documents show. That's a rate that far eclipses the rest of the residential care system, statistics from a similar timespan suggest.

Children's home market 'run in the interests of the providers'

The report also warns that children in homes are more likely to be placed far from family and to run away. In 2012-13, 9% of children in homes went missing as opposed to 1% in foster care. In 2013, 31% of children in homes were living outside their local authority boundary and more than 20 miles from home, compared to 10% of children in foster placements.

Ann Coffey MP, chair of the All-Parliamentary Group on Missing Children, described the children's care market as "run in the interests of the providers, not in the interests of children and young people."

Overall, in 2014, 25% of children in care were living in homes deemed 'adequate' by Ofsted, 59% in 'good' homes and only 16% in homes deemed 'outstanding'. Children have been placed in homes deemed adequate or worse by 97% of local authorities and the number of homes deemed inadequate rose from 6% in 2013-14 to 9% in 2014-15.

The largest providers of children's care include the Cambian Group, Acorn Care and Education Group, the Keys Group and the Priory Group.

Many of these groups are being run for profit, with the children's home market worth £7bn in England. For example, in 2014 the Cambian Group's revenue increased by 12% to £240.6m and the CEO received a total remuneration package worth £9.4m.

However, 11% of staff in private children's homes are being paid at or below the living wage and staff work on average 38.6 hours each week, compared to 33.9 hours in state-run homes.

If there was ever an advert to bring children's services back into public ownership then this would be it. Poorly staffed and poorly trained homes with a never ending list of safeguarding issues both for staff and for young people. Whenever i raised any feedback or criticism it was immediately shut down and i was told to make do.

Most shambolic head office function I've ever worked with every month someone in the home wasn't paid correctly, HR were never available and took days to respond even in emergencies. Recruitment were on another planet and were utterly clueless as to what working in a children's home was actually like which regularly in the home being regularly staffed with over 50% of agency workers.

I really fear for the future of the industry as over the last 6 months Keys had numerous large acquisitions throughout England and Wales so their practices are only going to become more commonplace.

My advice for anyone considering working for them is quite simply don't and find a job in children's

services with a more established provider or a local council and if you find yourself in the misfortune of currently working there join a union!

Troubled care home to restrict numbers

Admissions to a troubled care home on the south Shropshire border will be limited in an attempt to placate furious residents, it was revealed today.

The measure is one of several announced by Keys Group, which operates Mill House Care Home in Paytoe Lane, near Leintwardine. The company will also have meetings with the parish council every two months.

Last month residents, including Only Fools and Horses star John Challis, demanded action from Keys Group after claiming the home, which takes vulnerable children, had caused a decade of rural unrest.

The meeting heard how West Mercia Police had been forced to conduct continuous searches for missing children and rural tensions had risen in February when Mr Challis's home, Wigmore Abbey, was raided by two youngsters who had absconded from Mill House, which is just 50 yards away.

today, after reviewing residents' comments, Keys Group released a joint statement with Adforton Parish Council.

Keys Group bosses said they wanted to 're-establish and improve' Mill House's relationship with residents and would take a number of steps to better the situation.

The statement said: "Following a meeting held with representatives from the parish council and Keys, it has been agreed that we will meet together every two months to improve communication and monitor the situation and impact of the home on the local community of Paytoe.

"Keys are keen to re-establish and improve relationships between the home and local residents. Keys will limit admissions to the home whilst relationships improve."

It also said that it would plant a hedge around the boundary of the fence subject to permission and Keys would continue to operate the home for at least another 18 months.

TWO Wrexham-based child care workers have been suspended from duty after a vulnerable young person absconded on a day trip to the North Wales coast.

Ben Berry and David Corrigan who appeared before a Social Care Wales fitness to practice panel were both found to have been dishonest about the incident.

They each faced nine charges each in relation to an incident in which a young person in their care left their sight and disappeared in Llandudno in May 2018 while they were employed by Keys Group.

The youngster was finally discovered in Preston in his home county of Lancashire, the panel heard in Mold.

Charges included a failure to ensure the young person referred to throughout the hearing as 'A' – had two-to-one supervision in accordance with a risk assessment, that they delayed contacting the police after 'A' went missing, that they provided false or inaccurate information to police and their management about the incident and that their conduct had been dishonest.

After midnight at a children's care home called Ivy Cottage in the summer of 2010, a gap-toothed 15-year-old boy named Aaron Leafe turned on the taps in the bathroom and kept them running. A staff member knocked on the door, and Aaron opened it a crack. On the nearby floor were pyjama bottoms soaked in blood.

"Have you cut yourself?" the staff member asked.

Aaron had slashed his right arm repeatedly. In his bedroom, staff found two handwritten suicide notes in a folder he had labeled "Dad".

This was at least the 23rd time that Aaron had hurt or tried to kill himself, and it fell to Keys Group, Britain's second-largest private children's care home company, to protect him from himself. Keys makes millions each year charging taxpayers for the care of vulnerable children around Britain, which typically house between one and five kids. But a cache of internal documents obtained by BuzzFeed News reveals that, for years, Keys cut corners in its drive for profit — with devastating consequences.

The homes, and staff within the homes can be really good and friendly people.


Cons





























Sorry if I am late in responding to my neighbours planning application but I have just read the objections to this plan for the Kingsway Club in Cleethorpes.

The Idea of a no steps Kingsway Club is great for the current members of the Club, average age I guess 55 who like me are challenged with the amount of access steps. At 72, I can do it but always worry, so it is much easier to have a level access way as proposed. Disabled People will then also be able to access and fully enjoy the benefits of the Club.

The Club already utilises its outside front area in the summer, This competes with its neighbours' use of their frontage and the nearby pubs frontage and chairs on the side street walkway. Neither the nearby Pub, Willys or the Kingsway have music playing outside and the weather naturally limits outside time to a minimum. If limits are now decided necessary by the planners, I suggest they should apply equally to all on the Kingsway frontage.

Flat 4 comments they have the only terrace on the seafront, Untrue, They have a terrace at the rear of the property whilst I in Kingsway Court have a sea view balcony facing the Kingsway with 5 adjacent flat owners. Having spoken to all 5 other owners they share my view there is no noise problem, in fact the club closes most weekday nights about 20.30 hours so I suggest the Taxi Doors Banging and noise is coming from the other nearby Pub, Perhaps the compliant hearing these noises is hearing them from below his window from an adjacent Pub. Artists are on about every 6 weeks starting at 1830 hours and finishing about 21.00 hours. Not a problem.

Noise from the Beer Garden may have been louder during Covid Restrictions when there was no inside building access allowed, ie all outside, but that was the same everywhere. Fortunately that temporary Lockdown position has now passed. There are no music amplifiers to my knowledge in the Beer Garden.

The club must be the least police etc visited in Cleethorpes as the current owners have imposed strict control of their club. Just ask the police when they can remember visiting last?.

The objectors from Flat 1, 2 & 4 are all tenants of the family owning all the adjacent properties except the Kingsway Club and could be trying to influence the planning authority to monopolize the area for their own plans. Why be afraid of an Independent.?

I live as near as anyone to the club and have never had any issues with their operation so please pass these necessary improvements which will help Cleethorpes achieve its recently declared Aim to become an all year destination. not just a summer visitors place
