

The North East Lincolnshire Borough Council
A1173, Kiln Lane (part), Edison Road and Turing Road Speed Limit
(No. 19-25A) Order 2021

Notice is hereby given that the North East Lincolnshire Borough Council, propose to make a Speed Limit Order under powers contained in the Road Traffic Regulation Act 1984 as amended, the effect of which will be as follows:-

1. To revoke the de-restricted road status on the A1173 Stallingborough from a point 74 metres from the Stallingborough Interchange junction to the Kiln Lane roundabout junction (including all of the roundabout).
2. To introduce a 50mph speed limit on the A1173 Stallingborough from a point 74 metres north-east of the Stallingborough Interchange roundabout junction in a north-easterly direction for a distance of 350 metres.
3. To introduce a 40mph speed limit on the A1173 Stallingborough commencing 350 metres north-east of the Stallingborough Interchange roundabout junction in a north-easterly direction, including all of the roundabout junction with Edison Road and Turing Road, up to and including the Kiln Lane roundabout
4. To introduce a 40mph speed limit on Edison Road, Stallingborough from the A1173 roundabout junction in a south-easterly direction for a distance of 40 metres.
5. To introduce a 40mph speed limit on Turing Road, Stallingborough from the A1173 roundabout junction in a north-westerly direction for a distance of 39 metres.
6. To introduce a 40mph speed limit on Kiln Lane, Stallingborough from the Kiln Lane roundabout junction in a north-easterly direction to a point 75 metres south-west of the centre-point of the roundabout junction with North Moss Lane
