

Officer Decision Record

1. Subject and details of the matter (to include reasons for the decision)

This Officer Decision Record (ODR) is to obtain approval to submit a planning application for artwork by Annabel McCourt 'Human Murmurations' to be attached to Wilkinson's Wall at St James' Square. This forms part of the Public Realm artwork contract awarded to Our Big Picture in December 2019, as part of the Cultural Development Fund (CDF) Programme 'Grimsby Creates' in accordance with Cabinet decision DN.7 dated 5 June 2019.

2. Is it a Key Decision as defined in the Constitution?

No, this is not a key decision.

The decision is in accordance with the delegations established in relation to the CDF programme through the Cabinet approval of 5 June 2019 (Cabinet Decision Notice DN.7) and the delegations established in relation to the St James Square Public Realm Project through the Cabinet approval of 11 March 2019 (Cabinet Decision Notice DN.72).

The ODR of 17 February 2020 approves the appointment of the Public Art Consultant for St James Square.

3. Details of Decision

Following the selection and commissioning process for two artists to prepare designs for public art in St James' Square, Grimsby, this Officer Decision Record is for the submission of a planning application for the permanent installation of the artwork 'Human Murmurations' to Wilkinson's Wall adjacent to St James' Square, Grimsby.

The artwork is to be attached to the wall facing the Square. Wilkinson's and the property owner have provided consent for this activity to take place.

The artwork piece is expected to be very low maintenance and taking only a couple of days to install. The artwork comprises of a number of small copper silhouettes (approx. 400 ranging in size from 3x3cm to 18x24cm) attached to a stainless-steel framework. It will be high enough on the wall to discourage vandalism and CCTV will cover the location. A periodic safety inspection may be required to check all fixings remain secure.

Subject to planning the intention is for the artwork to be installed by June 2021 to coincide with completion of capital works, other artwork (etched pathway and benches) and re-opening of the space to the public.

No this is not an urgent decision.

5. Anticipated outcome(s)

To allow submission of a planning application, the subsequent approval of which will enable key outputs of the scheme to be delivered, including an expected increase in footfall in the area and the positive knock-on effect to trade.

The artwork itself captures the silhouette of hundreds of local people as a flock moving as one in their own unique ways. This additionally demonstrates and enhances local pride, freedom of movement, embracing community and a sense of belonging.

6. Details of any alternative options considered and rejected by the officer when making the decision

Alternative location – At the present time there are no plans for an alternative location. We have been in dialogue with Wilkinson's for several months and they are supportive of the proposal. There are limited alternative options for artwork of this scale and type within the realms of St James' Square.

Do nothing – this would not accord with the ambitions set out in the successful funding applications for CDF and Humber LEP LGF.

In the unlikely event that Wilkinson's relinquish the building and a new leaseholder does not want to retain the artwork, The Council would be responsible for the removal and reinstatement of the wall. It is envisaged that the artwork will be attached in several places by drilling and fixing into the mortar joints and the cost of reinstatement would be minimal.
