The County Council of Humberside (hereinafter referred to "the Council") in exercise of its powers under Sections 82(2) and 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the consent of the Secretary of State for Transport in accordance with Part II of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. This Order shall come into operation on the 12th day of July 1985 and may be cited as The County of Humberside (Cleethorpes Borough) (A1098, New Waltham and B1219, Humberston) (Restricted Roads and Variation) Order 1985.
- 2. The lengths of road specified in Schedule 1 to this Order shall be restricted roads for the purposes of Section 81 of the Act of 1984.
- 3. The Order specified in Column 1 of Schedule 2 to this Order shall be revoked to the extent specified in Column 2 of the said Schedule.
- 4. The Order specified in Column 1 of Schedule 3 to this Order is hereby varied to the extent specified in Column 2 of the said Schedule

SCHEDULE 1

30 mph Speed Limit

 A1098 - Station Road New Waltham that length of the Al098 Station Road, New Waltham, extending from its junction with the Al6 Trunk Road at the Toll Bar Roundabout in an easterly direction to its junction with the Al098 Peaks Lane and the Bl219, Humberston Avenue, a total distance of 1004 metres.

 B1219 - Humberston Avenue, Humberston that length of the B1219, Humberston Avenue, Humberston extending from the junction with the A1098, Peaks Lane in an easterly direction for a distance of 200 metres.
