## **The North East Lincolnshire Borough Council (B1219 Humberston Avenue) (40mph Speed Limit) (Revocation) (No. 20-08) Order 2021**

North East Lincolnshire Council, hereinafter referred to as “the Council”, in exercise of powers under Sections 82, 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “The Act of 1984”), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:—

**Title**

**Revocation**

The order referred to in Schedule 1 shall be revoked to the extent described in Column 2 of Schedule 1 from the date that this Order comes into operation.

**Definitions**

3.1

In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

**“The Act of 1984”** means The Road Traffic Regulation Act 1984;

**“Council”** means North East Lincolnshire Borough Council and includes any authorised agents appointed by or acting on behalf of the Council for the purposes of any function under the provisions of this Order;

**“Traffic Regulation Order”, “Order” or “TRO”** have the same meaning respectively, that being an Order made under powers contained within The Act of 1984;

For the purpose of this Order unless otherwise specified all references to any documents including Statutory Instruments, Regulations and policies and procedures of the Council relate to the current version of those documents as amended or substituted from time to time.
