Antisocial Behaviour, Crime and Policing Act 2014 **Public Spaces Protection Order** **East Marsh Area 2, Grimsby Order 2021**

North East Lincolnshire Council, in exercise of its powers under Section 59, 64 & 72 of the Antisocial Behaviour, Crime and Policing Act 2014 ("the Act") hereby makes the following Order:-

1. This Order shall come into operation on the 23rd June 2021 for up to 3 year period and may be cited as the North East Lincolnshire Borough Council East Marsh Area 2, Grimsby Public Spaces Protection Order - 2021.
2. This Order has been made in response to the crime and anti-social behaviour that the Council is aware is occurring in the area. The Council believes that the restriction of public access will assist in reducing the level of crime and anti-social behaviour occurring and improve the quality of life for the residents in the area.
3. Failure to comply with the Order by continuing to enter the Restricted Area to commit anti-social behaviour will result in an offence under s.67 Anti-Social Behaviour, Crime and Policing Act 2014.
4. A person guilty of an offence under section 67 is liable on summary conviction to a fine not exceeding £1,000.
5. The public right of way along the highways described in Schedule 1 (the restricted area) shall be restricted at all times and the restriction will continue for a period of up to 3 years.
6. An alternative route for pedestrian access is described in Schedule 2.
7. Those persons described in Schedule 3 shall be exempt from the provisions of this Order and upon their request keys will be made available to them.
8. The Council is hereby authorised to install, operate, and maintain a barriers at locations indicated on the attached plan numbered 6, 7, 8, 9, 10, 11, 12, 13, 14, 15 and 16 to enable the enforcement of the restriction. The person responsible for operating and maintaining the said barrier is the Chief Legal and Monitoring Officer, Municipal Offices, Town Hall Square, Grimsby, North East Lincolnshire DN31 1 HU
9. The conditions set out in Section 59, 64 and 72 of the Act have been complied with for the purpose of making this Order.

SCHEDULE 1

The public path that runs adjacent to 17-20 Millom Way indicated by a solid black line and numbered 6 on the attached plan.

The public path in between 17-20 Millom Way on one side and 21-24 Millom Way on the other side indicated by the solid black line and numbered 7 on the attached plan.

The public path in between 15 Millom Way on one side and 21-24 Millom Way on the other side indicated by the solid black line and numbered 8 on the attached plan.

The public path in between 14 Millom Way indicated by the solid black line and numbered 9 on the attached plan.

The public path in between 1 Buttermere Way indicated by the solid black line and numbered 10 and 11 on the attached plan.

The public path that links Victor Street and Willing Way indicated by the solid black line and numbered 12, 13 and 14 on the attached plan.

The public path at the rear of 6, 8 and 10 Willing Way indicated by the solid black line and numbered 15 on the attached plan.

The public path at the rear of 159, 161, 163, 165, 167 and 169 Wellington Street indicated by the solid black line and numbered 16 on the attached plan.

SCHEDULE 2

Via as appropriate Victor Street, Wellington Street, Albion Street, Buttermere Way, Millom Way, Willing Way and by unaffected paths.

SCHEDULE 3

The occupiers of premises adjoining or adjacent to the highways referred to in Schedule 1.

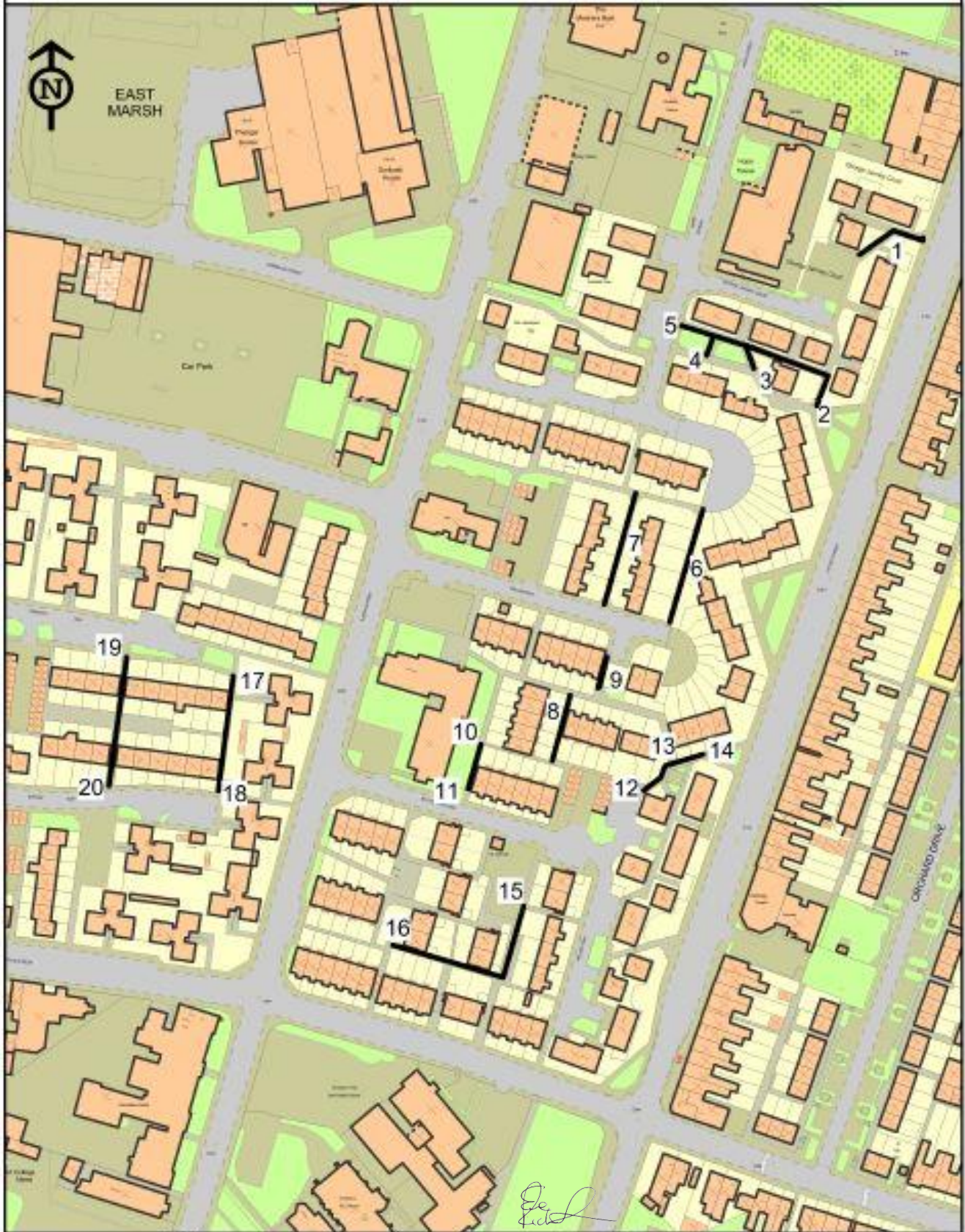
