Approval is sought to sign the Government's contract variation letter which relates to the 'Welcome Back' (WBF) and 'Coastal' Funds' (CF) extension, in accordance with the Cabinet Decision, 16th June 2021:

DN.20 WELCOME BACK FUND

Cabinet considered a report from the Portfolio Holder for Economic Development, Housing and Tourism seeking approval to accept resultant grant funding from the Ministry of Housing, Communities and Local Government (MHCLG).

RESOLVED –

1. Subject tothe Ministry of Housing, Communities and Local Government approving submitted plans, authority be delegated to the Executive Director for Environment, Economy and Resources, in consultation with the Portfolio Holder for Economic Development, Housing and Tourism, to accept resultant grant funding on behalf of the Council.

2. That authority be delegated to the Executive Director for Environment, Economy and Resources, in consultation with the Portfolio Holder for Economic Development, Housing and Tourism, to implement proposals and deal with all matters arising from and ancillary to the above.

3. That the Assistant Director Law, Governance and Assets (Monitoring Officer) be authorised to complete and execute all requisite legal documentation in relation to the matters outlined above.

2. Subject and details of the matter (to include reasons for the decision)

WBF builds on the £50m Reopening High Street Safely Fund (RHSS) allocated to councils in 2020. North East Lincolnshire (NEL) was allocated £141,143 RHSS which is currently being delivered. In April 2021, the Council was allocated an additional £141,143 WBF, plus £100,000 CF to extend the RHSS Programme. At Cabinet on 16

June 2021, it was resolved to accept the funding. The Council has now received a contract variation letter from Government and this decision seeks approval to sign it.

3. Decision being taken

Government has increased the original grant allocation of RHSS, to include additional funds for WBF and CF programmes and the decision required is therefore as follows:

1. In line with current delegations the Executive Director for Environment, Economy and Resources, in consultation with the Portfolio Holder for Economic Development, Housing and Tourism, supports the participation in further funds and authorises the Monitoring Officer to sign the requisite contract variation.

5. Anticipated outcome(s)/benefits

The additional grant supplied through the Government's European Development Funded, WBF and CF will make a significant contribution to the Council's strategic objective of a 'Stronger Economy' and 'Stronger Community'. This funding has been allocated to North East Lincolnshire to support the return to high streets and tourism areas safely and help build back better from the pandemic. The WBF forms part of wider support government is providing to communities and businesses, to protect jobs, support the most vulnerable and ensure no one is left behind as the Covid-19 pandemic continues to be tackled and begin to build back better. The fund will allow North East Lincolnshire Council to put in place additional measures to create and promote a safe environment for local businesses, particularly in high streets. It will also pay for a range of activities which will encourage local people to revisit our key tourism areas safely.

Do Nothing - Not responding to the Government's offer of funding would not achieve the Council's key strategic aims for a stronger economy, specifically in terms of economic recovery and growth.

Not accept the allocated funding - This will result in losing the opportunity to support the safe reopening of businesses in North East Lincolnshire and welcoming back the community and visitors to our tourism areas.
