THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL (REMEMBRANCE PARADE - PEAKS LANE AND SURROUNDING STREETS, NEW WALTHAM- TTRO 21-137-3) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), the Highway Authority for the above-mentioned road in the Borough of North East Lincolnshire, is satisfied that a temporary road closure be imposed on the below mentioned roads by reason of allowing the safe facilitation of the Remembrance Day Service between 08:00hrs and 14:00hrs on Sunday 14 November, 2021

Peaks Avenue from its junction with Peaks Lane to its junction with Anningson Lane

Incorporating the junction entrance to Holme Lane to the Give Way section of

Peaks Lane joining Peaks Avenue

There will also be a manual STOP to traffic whilst the 2minutes silence is being observed from 10:55am – 11:05am.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all powers them enabling in that behalf hereby make the following Order:

- 1. A temporary road closure (for the purpose of allowing the safe facilitation of the Remembrance Day Service) on Peaks Lane, New Waltham.
- 2. The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.
- 3. The Order will come into operation on **Sunday 14 November, 2021** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.
- 4. Exemptions to the order will be for authorised vehicles only, as listed below.
 - Liveried Local Authority Vehicles (ENGIE/ NELC)
 - Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
 - Authorised Contractors / Utilities / Waste

The Order may be cited as "The North East Lincolnshire Borough Council (Remembrance Parade – Peaks Lane and Surrounding Streets, New Waltham – TTRO 21-137-3), (Temporary Prohibition of Traffic), Order 2021".
