THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL (REMEMBRANCE PARADE - A SECTION OF HIGH STREET AND SURROUNDING STREETS, LACEBY - 21-137-4) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), the Highway Authority for the above-mentioned road in the Borough of North East Lincolnshire, is satisfied that a temporary road closure be imposed on the below mentioned roads by reason of allowing the safe facilitation of the Remembrance Day Service between 08:00hrs and 14:00hrs on Sunday 14 November, 2021

Austin Garth from its commencement at the British Legion to its junction with New Chapel

Lane

New Chapel Lane from its junction with Austin Garth to its junction with High Street

High Street from its junction with New Chapel Lane to its junction with Cemetery Road

Cemetery Road from its junction with High Street to its junction with Altoft Close

Continuing to its junction with Knights Close. Terminating at its junction with

Cemetery Crescent.

Adjoining Streets may be affected for a short period of time whilst the Parade passes but will be reopened as soon as it is safe to do so.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all powers them enabling in that behalf hereby make the following Order:

- 1. A temporary road closure (for the purpose of allowing the safe facilitation of the Remembrance Day Service) on Austin Garth, New Chapel Lane, High Street and Cemetery Road, Laceby.
- 2. The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.
- 3. The Order will come into operation on **Sunday 14 November, 2021** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.
- 4. Exemptions to the order will be for authorised vehicles only, as listed below.
 - Liveried Local Authority Vehicles (ENGIE/ NELC)
 - Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
 - Authorised Contractors / Utilities / Waste

The Order may be cited as "The North East Lincolnshire Borough Council (Remembrance Parade – High Street and Surrounding Streets, Laceby – TTRO 21-137-4), (Temporary Prohibition of Traffic), Order 2021".
