THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a) A SECTION OF B1219 STATION ROAD, NEW WALTHAM (TEMPORARY PROHIBITION OF TRAFFIC– TTRO 21-138) ORDER 2021

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, from **PROCEEDING** along or **STOPPING** on the below sections of highway:

 A section of B1219 STATION ROAD – Part Length from TOLLBAR SCHOOL to TOLLBAR AVENUE, including the east and west entry and exit arms of roundabout with A16 LOUTH ROAD.

For the avoidance of doubt the B1219 STATION ROAD / A16 LOUTH ROAD roundabout junction will remain open for northbound and southbound traffic travelling along the A16 LOUTH ROAD, at all times.

Alternative route: B1203 GRIMSBY ROAD, B1203 WALTHAM ROAD, A1243 LOUTH ROAD, LOUTH ROAD ROUNDABOUT, A16, LOW FARM ROUNDABOUT, A1098, PEAKS LANE, B1219 STATION ROAD.

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by North East Lincolnshire Council. These works are detailed as the application of antiskid carriageway surfacing at Tollbar roundabout.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday**, **06 December 2021** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (ENGIE/ NELC)
- Authorised Contractors
