### **Operational Officer Decision Record**

## Where the decision has a financial value of between £100k - £350k and does not have a significant impact on two or more wards

**1. Subject and details of the matter** (to include reasons for the decision and detail of any previous cabinet decision)

Approval is sought to award the contract for the purchase of two new 18 tonne fixed body road salting vehicles to replace two current aging road salting vehicles.

The following desirable requirements are to be installed on both vehicles:

- Vinyl graphics to be guaranteed against fading, shrinkage, cracking or peeling for 5 years from the vehicle delivery date.

- The Customer to be invited to factory to finalise vehicle build specification.
- Seat belts to be red.
- Allison Full Auto transmission, or technical equivalent.
- Heated windscreen.
- Heated mirrors.

- Vehicle to be fitted with mapping and navigation system which provides audible "turn by turn" instructions which can be programmed to 'auto salt' pre-determined routes, including settings for salt on / off, road width, symmetry of spread, uplift rate function. - Roller easy sheet system, or similar equivalent sheeting system, to be fitted for use on gritter body to prevent water ingress.

The whole life value of the contract is £234,924.02

The maximum duration of the contract is 48 months.

(Officer Decision Record 18th October 2021) Approval for Executive Director Environment, Economy and Resources to commence the procurement process for two new 18 Tonne Fixed Body Road Salting Vehicles and in consultation with the Portfolio Holder for Environment and Transport to make an award and deal with ancillary matters arising.

An exception to access the YPO framework was approved.

A further competition was run under the YPO Specialist Vehicles Framework (960): Lot 5 - Purchase of Winter Maintenance Vehicles FC1609.

Following the conclusion of the evaluation process, the Most Economically Advantageous Tenderer has been identified as Econ Engineering Limited.

#### 2. Decision being taken

That the Executive Director for Environment, Economy and Resources in consultation with the Portfolio Holder for Environment and Transport approves the purchase of two new 18 tonne fixed body road salting vehicles and the purchase of the following desirable requirements for both vehicles:

- Vinyl graphics to be guaranteed against fading, shrinkage, cracking or peeling for 5 years from the vehicle delivery date.

- The Customer to be invited to factory to finalise vehicle build specification.

- Seat belts to be red.
- Allison Full Auto transmission, or technical equivalent.
- Heated windscreen.
- Heated mirrors.

- Vehicle to be fitted with mapping and navigation system which provides audible "turn by turn" instructions which can be programmed to 'auto salt' pre-determined routes, including settings for salt on / off, road width, symmetry of spread, uplift rate function.

- Roller easy sheet system, or similar equivalent sheeting system, to be fitted for use on gritter body to prevent water ingress.

The decision will authorise awarding one contract for the purchase of two new 18 tonne fixed body road salting vehicles with the above-mentioned desirable requirements to Econ Engineering Limited.

#### 3. Anticipated outcome(s)/benefits

The contract for the purchase of two new 18 tonne fixed body road salting vehicles with the above-mentioned desirable requirements is awarded to Econ Engineering Limited.

## 4. Details of any alternative options considered and rejected by the officer when making the decision

Do nothing and not award option is an option, but was not felt to be feasible, as there is a continuous need to improve fleet efficiency across all areas and fleet is evaluated each year and only replaced on a need basis when the item has come to the end of its life and is no longer cost effective to keep and maintain. To do nothing would not improve the cleanliness of the Council's fleet and would impact on our commitment to reduce our environmental impact.

Econ Engineering Limited have been identified as the Most Economically Advantageous Tenderer and so there is no reason to not award.
