NEW FIBRE BROADBAND CONNECTION WORKS – B1213 HAINTON AVENUE AND SURROUNDING STREETS

(TEMPORARY PROHIBITION OF TRAFFIC & ONE-WAY TRAFFIC FLOW – TTRO 21-130) ORDER 2021

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be

- a) that no person shall cause or permit any motor vehicle from PROCEEDING along or STOPPING on the below sections of highway:
 - A section of SIXHILLS STREET Part Length from its junction with B1213 HAINTON AVENUE to its junction with HENEAGE ROAD.
 ALTERNATIVE ROUTE: HENEAGE ROAD, PASTURE STREET, B1213 HAINTON AVENUE.
 - A section of CATHERINE STREET Part Length from its junction with B1213 HAINTON AVENUE to its junction with HENEAGE ROAD.
 ALTERNATIVE ROUTE: B1213 HAINTON AVENUE, TASBURGH STREET, HENEAGE ROAD
 - A section of CATHERINE STREET Part Length from its junction with WILLINGHAM STREET to its junction with B1213 HAINTON AVENUE.
 ALTERNATIVE ROUTE 1: WILLINGHAM STREET, WINTRINGHAM ROAD, B1213 HAINTON AVENUE
 ALTERNATIVE ROUTE 2: B1213 HAINTON AVENUE, SIXHILLS STREET, WILLINGHAM STREET
 - A section of HENEAGE ROAD Part Length from its junction with PASTURE STREET to its junction with SIXHILLS STREET.
 ALTERNATIVE ROUTE 1: PASTURE STREET, B1213 HAINTON AVENUE, SIXHILLS STREET
 ALTERNATIVE ROUTE 2: SIXHILLS STREET, B1213 HAINTON AVENUE, ELEANOR STREET, CONVAMORE ROAD, PASTURE STREET
 - A section of EDWARD STREET Part Length from its junction with PASTURE STREET to
 its junction with SIXHILLS STREET.
 ALTERNATIVE ROUTE 1: PASTURE STREET, HENEAGE ROAD, SIXHILLS STREET
 ALTERNATIVE ROUTE 2: SIXHILLS STREET, B1213 HAINTON AVENUE, ELEANOR
 STREET, CONVAMORE ROAD, PASTURE STREET
 - A section of THOMAS STREET Part Length from its junction with PASTURE STREET to its junction with SIXHILLS STREET.
 ALTERNATIVE ROUTE 1: PASTURE STREET, EDWARD STREET, SIXHILLS STREET ALTERNATIVE ROUTE 2: SIXHILLS STREET, B1213 HAINTON AVENUE, ELEANOR STREET, CONVAMORE ROAD, PASTURE STREET
 - A section of CONVAMORE ROAD Part Length from its junction with PASTURE STREET to its junction with SIXHILLS STREET.

ALTERNATIVE ROUTE: PASTURE STREET, THOMAS STREET, SIXHILLS STREET

- A section of SIXHILLS STREET Part Length from its junction with WILLINGHAM STREET to its junction with SHEEPFOLD STREET.
 - ALTERNATIVE ROUTE: WILLINGHAM STREET, PASTURE STREET, B1213 HAINTON AVENUE, BRADLEY STREET, EASTGATE, ROBINSON STREET EAST

- A section of SHEEPFOLD STREET Part Length from its junction with SIXHILLS STREET to its junction with ROBINSON STREET EAST.
 ALTERNATIVE ROUTE: WILLINGHAM STREET, PASTURE STREET, B1213 HAINTON AVENUE, BRADLEY STREET, EASTGATE, ROBINSON STREET EAST
- A section of WILLINGHAM STREET Part Length from its junction with WINTRINGHAM ROAD to its junction with PASTURE STREET.
 (Due to the length of road concerned, works will be undertaken in 60 metre phasing to minimise disruption to local residents. Access and parking will be reinstated at the end of each day)
 - ALTERNATIVE ROUTE: SIXHILLS STREET, SHEEPFOLD STREET, PASTURE STREET
- A section of SIXHILLS STREET Part Length from its junction with HENEAGE ROAD to its junction with EDWARD STREET.
 - ALTERNATIVE ROUTE: SIXHILLS STREET, EDWARD STREET, PASTURE STREET, HENEAGE ROAD
 - ALTERNATIVE ROUTE 2: SIXHILLS STREET, B1213 HAINTON AVENUE, ELEANOR STREET, CONVAMORE ROAD, PASTURE STREET, EDWARD STREET
- A section of SIXHILLS STREET Part Length from its junction with THOMAS STREET to its junction with EDWARD STREET.
 - ALTERNATIVE ROUTE 1: SIXHILLS STREET, THOMAS STREET, PASTURE STREET, EDWARD STREET
 - ALTERNATIVE ROUTE 2: SIXHILLS STREET, B1213 HAINTON AVENUE, ELEANOR STREET, CONVAMORE ROAD, PASTURE STREET, THOMAS STREET
- A section of CONVAMORE ROAD Part Length from its junction with SIXHILLS STREET to its junction with ROPERY STREET.
 - ALTERNATIVE ROUTE: ROPERY STREET, LADYSMITH ROAD, SIXHILLS STREET
- A section of MARGARET STREET Part Length from its junction with B1213 HAINTON-AVENUE to its junction with HENEAGE ROAD ALTERNATIVE ROUTE: HENEAGE ROAD, SIXHILLS STREET, B1213 HAINTON AVENUE
- A section of B1213 HAINTON AVENUE Part Length from its junction with PASTURE STREET to its junction with SIXHILLS STREET.
 ALTERNATIVE ROUTE: B1213 HAINTON AVENUE, ELLIS WAY, A16 PEAKS PARKWAY, B1212 WELHOLME ROAD, B1213 HAINTON AVENUE.
- A section of LADYSMITH ROAD Part Length from its junction with JULIAN STREET / SIXHILLS STREET to its junction with DURBAN ROAD.
 ALTERNATIVE ROUTE: DURBAN ROAD, HUMBERSTONE ROAD, ELEANOR STREET, CONVAMORE ROAD.
- A section of CATHERINE STREET Part Length at its junction with WILLINGHAM STREET.
 TEMPORARY OBSTRUCTION 15 MINUTE DELAY, ACCESS ONLY.
- A section of SIXHILLS STREET Part Length from its junction with WILLINGHAM STREET to its junction with B1213 HAINTON AVENUE.
 ALTERNATIVE ROUTE: B1213 HAINTON AVENUE, CATHERINE STREET, WILLINGHAM STREET.

This above temporary road closures are required because works are being or are proposed to be executed on or near the road by TELEC UTILITIES LTD. These works are detailed as excavation to facilitate the installation of two-way poly duct across the carriageway for new fibre optic broadband.

- b) that no person shall cause or permit any motor vehicle from PROCEEDING along the below sections of highway otherwise than in a northerly direction:
 - A section of WILLINGHAM STREET Part length from its junction with CATHERINE STREET to its junction with SIXHILLS STREET.

The above temporary alteration to traffic flow is necessary to facilitate an effective diversion route for works programmed on SIXHILLS STREET, between the junction of WILLINGHAM STREET and B1213 HAINTON AVENUE.

The above measures will be phased in order to minimise disruption to the public. Definitive dates and times will be notified by on-site advanced warning signs.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Monday**, **20 December 2021** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Liveried Local Authority Vehicles (ENGIE/ NELC)
- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors / Utilities / Waste

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), New Fibre Broadband Connection Works – B1213 Hainton Avenue and surrounding streets (Temporary Prohibition Of Traffic & One-Way Traffic Flow – TTRO 21-130), Order 2021"
