THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL ROAD TRAFFIC REGULATION (SPECIAL EVENTS) ACT 1984 – SECTION 16A NEW YEARS DAY 2022 10KM RACE, CLEETHORPES (TEMPORARY PROHIBITION OF TRAFFIC– TTRO 21-145) ORDER 2022

<u>WHEREAS</u> the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 16 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle to **PROCEED** along or **STOP** on the below sections of highway:

KINGS ROAD (NORTHBOUND CARRIAGEWAY) – from its roundabout junction with NORTH SEA LANE / ST ANTHONYS BANK ROAD to its junction with CROMWELL ROAD.

CROMWELL ROAD (WESTBOUND CARRIAGEWAY) – from its roundabout junction with KINGSWAY / KINGS ROAD to its junction with HARDYS ROAD.

HARDYS ROAD (SOUTHBOUND CARRIAGEWAY) – from its junction with CROMWELL ROAD to its junction with CHICHESTER ROAD.

CHICHESTER ROAD (WESTBOUND CARRIAGEWAY) – from its junction with HARDYS ROAD to its junction with TAYLORS AVENUE.

CHICHESTER ROAD (EASTBOUND CARRIAGEWAY) – from its junction with HARDYS ROAD to its junction with KINGS ROAD.

A1098 TAYLORS AVENUE (SOUTHWESTBOUND CARRIAGEWAY) – from its junction with CHICHESTER ROAD to its roundabout junction with A1031 HUMBERSTON ROAD / A1098 HEWITTS AVENUE.

A1031 HUMBERSTON ROAD (SOUTHEASTBOUND CARRIAGEWAY) – from its roundabout junction with A1098 TAYLORS AVENUE / A1031 HUMBERSTON ROAD / A1098 HEWITTS AVENUE to its roundabout junction with A1031 CHURCH AVENUE / PARK LANE / NORTH SEA LANE.

NORTH SEA LANE (EASTBOUND CARRIAGEWAY) – from its roundabout junction with A1031 HUMBERSTON ROAD / A1031 CHURCH LANE to its roundabout junction with ANTHONYS BANK ROAD / KINGS ROAD.

Alternative route: KINGSWAY (SOUTHBOUND), KINGS ROAD (SOUTHBOUND) NORTH SEA LANE (WESTBOUND), A1031 HUMBERSTON ROAD (NORTHWESTBOUND), A1098 TAYLORS AVENUE (NORTHEASTBOUND)

This temporary prohibition is required to safely facilitate the New Years Day 2022 10k race being held by Cleethorpes Athletics Club.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Saturday**, **01 January 2022** and shall continue for a period of three days unless extended by Order of the Secretary of State for Transport.

Exemptions to the order will be for authorised vehicles only, as listed below.

- Emergency Vehicles (Fire, Police, Ambulance, Coast Guard)
- Authorised Contractors

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation (Special Events) Act 1984 – Section 16A, New Years Day 2022 10km Race, Cleethorpes (Temporary Prohibition Of Traffic – TTRO 21-145), Order 2022"
