

THE NORTH EAST LINCOLNSHIRE BOROUGH COUNCIL
ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)
LITTLE LONDON & ROXTON SIDINGS LEVEL CROSSING CLOSURES
(TEMPORARY PROHIBITION OF TRAFFIC– TTRO 21-146) ORDER 2021

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, pedestrian or pedal cycle, from **PROCEEDING** along the below sections of highway:

- A section of A1173 STALLINGBOROUGH ROAD – Part Length at the LITTLE LONDON LEVEL CROSSING including 20 metres of carriageway either side of the crossing.

Alternative route: A1173 STALLINGBOROUGH ROAD, A1173 RIBY ROAD, A18 BARTON STREET, B1211, B1211 BROCKLESBY ROAD, B1210 BROCKLESBY, B1210 STATION ROAD, B1210 IMMINGHAM ROAD, B1210 HABROUGH ROAD.

- A section of ROXTON ROAD, IMMINGHAM – Part Length at the ROXTON SIDINGS LEVEL CROSSING including 20 metres of carriageway either side of the crossing.

Alternative route: B1210 STALLINGBOROUGH ROAD, A1173 STALLINGBOROUGH ROAD, KEELBY ROAD, STALLINGBOROUGH ROAD.

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Network Rail. These works are detailed as repairs to the level crossing points.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Saturday, 08 January 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

It is not possible, on the grounds of safety, to provide exemptions to this Order other than to those undertaking the works.

The Order may be cited as "The North East Lincolnshire Borough Council, Road Traffic Regulation Act 1984 – Section 14(1)(a), Little London & Roxton Sidings Level Crossing Closures, (Temporary Prohibition Of Traffic – TTRO 21-146), Order 2021"
