**Public safety:** issues related to the exits and entrances to the club and the limited access available from the alleyway at the back

**Prevention of public nuisance:** I have been asked to represent some of the local residents to express their concerns about the reopening of these premises.

This property has only a narrow alley between it and the closest house in a row of terraced homes. The application includes a request for recorded music to be played until 12pm Monday to Thursday and until 1.30 pm Friday and Saturday. Given the close proximity to homes all licensed activities should conclude no later than 11.30.

The use of a microphone for activities such as music and bingo should also continue no later than 11pm and windows should always be closed whilst this is happening.

Deliveries should take place no earlier than 7am daily with the only exemption being 8.30 am on Sundays.

The use of the metal staircase at the front of the building is of concern as it does not look safe for anyone not wearing safety shoes.

There are concerns about people using the front of the premises for smoking, local residents are concerned about some of the young children living in the area witnessing this and feel this should be in an area not easily visible from the street or the windows of their homes.

There is already a lack of parking in the area and residents have also expressed concerns about this and other environmental issues such as litter.

**If possible please suggest alterations to the application that would resolve the problem mentioned above, again paying attention to the licensing objectives:**

Noise from the club needs to be limited by ensuring the use of a microphone to play music or take part in activities like bingo or sweepstakes etc does not take continue after 11pm and only when doors and windows are closed.

No playing of live music and all licensed activities to conclude no later than 11.30pm.

deliveries should be no earlier than 7am and 8.30 on Sundays.

The use of the metal stairway at the front of the building should be limited to day light hours.

The concerns about children seeing people standing about outside smoking would be eliminated by the provision of an area at the back of the building which has air conditioning provided to funnel the smoke away from residents homes and is walled to prevent view from the street or residents windows.

Concerns about litter etc would be satisfied by regular sweeping and cleaning around the premises. It is not clear how the lack of parking would be satisfied.
