Previous cabinet decisions

Cabinet considered a report (Forward Plan Ref No. CB 04/21/01) from the Deputy Leader and Portfolio Holder for Finance, Resources & Assets on 7 April 2021 on Heritage Assets 'At Risk'. The decision record (DN.119) confirmed that the following had been resolved:

- 1. That the release of capital funding to the value of £673,000 to enable investment works at the Scartho Cemetery Lodge, Waiting Rooms and Toilets, be approved.
- 2. That authority be delegated to the Executive Director for Environment, Economy and Resources, in consultation with the Portfolio Holder for Finance, Resources and Assets, to ensure that all necessary actions are carried out in relation to completing resolution 1 above.

While the majority of the heritage work at the Scartho Chapels has been completed, there is a small amount of outstanding heritage work to be undertaken. As the heritage capital budgets for the Scartho Cemetery buildings have now been combined and moved under Bereavement Services, this chapel work will be done at the same time as the Lodge/Waiting Rooms, in order to get the best value for money. The overall work required on Scartho Cemetery Chapels – Heritage at Risk was detailed in the report Cabinet considered at their meeting on 7 August 2019 (Forward Plan Ref No.

CB 07/19/04). The decision record (DN.28) confirmed that the following had been resolved:

That the Director of Resource and Governance be authorised to make the necessary arrangements to release the capital sum of £431,000 to allow urgent repairs to take place to Scartho Cemetery Chapel as part one (1) of the next phase of repairs to Council owned Heritage Assets.

2. Subject and details of the matter (to include reasons for the decision)

<u>Subject</u>

The subject matter is Scartho Cemetery Lodge, Waiting Rooms & Chapel.

Details of the matter

A contractor needs to be appointed to undertake heritage work on Scartho Cemetery Lodge, Waiting Rooms & Chapel. This Officer Decision Record seeks approval to appoint the contractor.

3. Decision being taken

This procurement was conducted in line with procedure. The tender was published on 18 November 2021, with a tender return date of 10 January 2022. Three tender bids were received, with one being disqualified on Quality. The remaining two tenders were evaluated by a cost-based evaluation with the lowest bid being £671,558.75.

The decision is:

That the Executive Director for Environment, Economy and Resources in consultation with the Deputy Leader & Portfolio Holder for Finance, Resources & Assets do award the contract to the successful contractor against the current Bereavement Services capital budget, to proceed to construction phase (as detailed on the attached (CLOSED) appendix).

The commencement of the project will remove the last of the Council owned heritage property assets from the 'At Risk' Register. Once the heritage work has been undertaken, the Scartho Cemetery Lodge can then be developed as the base for the provision of simple funeral services.

Key Decisions are defined in the Constitution as:
