PH.EE.1 **DECLARATIONS OF INTEREST**

There were no declarations of interests in respect of items on the agenda.

PH.EE.2 PETITION - REINSTATEMENT OF A PARKING PERMIT SCHEME ON ELM ROAD/ELM AVENUE, CLEETHORPES

The Chair invited the lead petitioner to present his petition.

Mr. Seddon, advised that parking had become more difficult recently particularly with the increasing high number of cars making parking nearly

impossible for local residents. Many employees and shoppers were choosing to use Elm Road for free parking rather than the Council owned car parks. Residents were now concerned that on their return home they would be unable to get parked outside their homes. There had also been an increase in car damage due to this issue. It was hoped that this could be resolved with the introduction of a parking permit scheme.

Councillor Brown, Ward Councillor for the area, was very concerned for local residents and particularly their families. He felt that due to Elm Road being located extremely close to Cleethorpes central shopping area, this was now causing the road to suffer from a lot of traffic. He was also concerned that local residents were now struggling to park outside their homes. He therefore fully supported the introduction of a parking permit scheme.

Ms. Swatman advised that they would assess the situation on Elm Road and if it was suitable for a scheme they would draw up some proposals and inform residents.

The Chair advised that 51% of residents needed to be in support of a parking permit scheme in order for it to be re-instated.

RESOLVED – That the petition be received and the current situation on Elm Road, Cleethorpes be assessed for suitability for a parking permit scheme.

PH.EE.3 **TRACKING**

The Portfolio Holder considered a report tracking the recommendations of previous meetings.

RESOLVED -

- (1) That, in relation to PH.ET.3 petition (School Initiative Road Safety, Alexandra Road, Grimsby), Officers report back to a future meeting with the results of the consultation.
- (2) That, in relation to, DNPH.ET.14 (petition, Habrough Flashing signs), there be continuing monitoring of the site.
- (3) That in relation to DNPH.ET.16 (petition Pedestrian Crossing Stallingborough), it be noted that Officers were awaiting confirmation of the location of the proposed crossing.
- (4) That in relation to DNPH.ET.31 (petition opposed to proposals for yellow lines on the resident side of Cromwell Road, Grimsby), this

be removed from the tracking report as it was noted that the scheme had now been implemented and this would continue to be monitored in the next school year.

- (5) That in relation to PH.ET.19 (Pelham Road, Immingham weight limit restriction), it be noted that the weight limit had now been approved and Officers were awaiting the signage to be installed. It be further noted that the Council needed to ensure the signage linked in with the timing of the opening of the new road.
- (6) That in relation to PH.ET.46 (Traffic Regulation Order, Dorothy Avenue, Waltham), this be removed from the tracking report as it was noted that a revised proposal had been undertaken and residents had now been informed.
- (7) That in relation to Traffic Regulation Order Chichester Road, Cleethorpes, this be incorporated into an upcoming scheme planned for later on this year.

There being no further business, the Portfolio Holder closed the meeting at 10.45 p.m.
