ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a)
FISH DOCK ROAD LEVEL CROSSING - ROWLANDSON STREET, GRIMSBY
(TEMPORARY PROHIBITION OF TRAFFIC – TTRO 22-021) ORDER 2022

WHEREAS the North East Lincolnshire Borough Council (hereinafter referred to as "the Council"), in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 hereby make the following Order the effect of which will be that **no person shall cause or permit** any motor vehicle, pedestrian or pedal cycle from **PROCEEDING** along the below sections of highway:

- A section of ROWLANDSON STREET, GRIMSBY – Part Length from a point 20 metres northeast of the FISH DOCK ROAD LEVEL CROSSING to a point 20 metres southwest of the FISH DOCK ROAD LEVEL CROSSING.

Alternative route (1): EASTSIDE ROAD, ROYAL STREET, LOCKHILL ROAD, LOCKHILL ROUNDABOUT, A180 CLEETHORPE ROAD, RIBY SQUARE

Alternative route (2): RIBY SQUARE, RIBY STREET, HUMBER STREET, A180 CLEETHORPE ROAD, LOCKHILL ROUNDABOUT, LOCKHILL ROAD, EASTSIDE ROAD

This temporary prohibition is required because works are being or are proposed to be executed on or near the road by Network Rail. These works are detailed as level crossing maintenance.

Works will be undertaken overnight between 23:30hrs and 08:30hrs to minimise disruption to traffic flows.

The Interpretation Act 1978 shall apply in the interpretation of the Order as it applies to the interpretation of an Act of Parliament.

The Order shall come into operation on **Saturday, 16 April 2022** and shall continue for a period of eighteen months unless extended by Order of the Secretary of State for Transport.

There will be no Exemptions to this order on the grounds of safety.

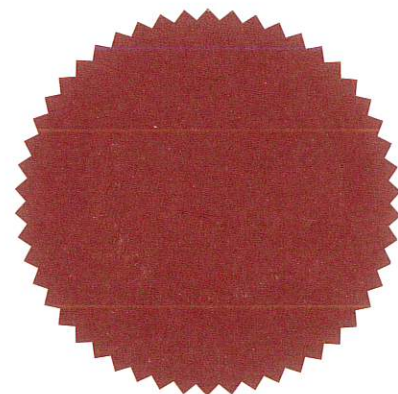
