# NEL.13 **REVIEW OF THE CONSTITUTION**

relevant Committee or Panel (non-executive arrangements) as the case may be.

- (2) That the amendments to the Contract Procedure Rules as detailed at Appendix 2 of the report now submitted, be approved.
- (3) That the amendments to the Financial Procedure Rules as detailed at Appendix 4 of the report now submitted, be approved.
- (4) That Article 4 (Decision Making) of the Constitution be updated to clarify officer decision making arrangements, as set out at Appendix 3 of the report now submitted.
- (5) That the terms of reference of the Executive and Scrutiny Liaison Board, as set out at Appendix 5 of the report now submitted, be approved.
- (6) That the recommendations of the Constitution Working Group, as set out in Section 6 of the report now submitted, be approved.
- (7) That the settled terms of reference of the Union Board, as set out at Appendix 6 of the report now submitted, be approved for inclusion in the Constitution together with all subsequent amendments required to integrate them into the Constitution being made in consultation with Group Leaders.
- (8a) That, accepting that the Place Board generally is not a true committee of the Council but a partnership of various bodies with common aims across the borough, the spirit of the draft tenets and stated aims of the Place Board, set out at Appendix 7 of the report now submitted, be approved in principle by Council on the understanding that once these crystallise they be incorporated appropriately into the Constitution by the Monitoring Officer in consultation with Group Leaders.
- (8b) That the proposal to incorporate the extant Health and Wellbeing Board into a "Part B" aspect of the Place Board (preserving the Health and Wellbeing Board's statutory standing and membership), subject to all governance arrangements afforded to a formal committee of Council, be approved.
- (9) That authority be delegated to the Monitoring Officer, in consultation with the Group Leaders, to make any amendments of a minor nature to the Constitution from time to time.
