NEL.101 MOTION TO THE COUNCIL

Council considered a motion submitted in accordance with the Council's Constitution, and requested by six Members of Council, to be proposed by Councillor Fenty and seconded by Councillor Harness as follows:

At the full Council meeting dated 8th February, 2017, there ensued a debate following a motion that raised concerns relating to the disposal of the Fitties Chalet Park.

It was resolved at that meeting, that the Ward Councillors of Humberston and New Waltham would meet with the prospective new owners of the Fitties Chalet Park and work with officers, with an objective of ensuring that those concerns be addressed and that adequate safeguards be implemented, in order for the Council to fulfil its duty of care as a good landlord.

The Ward Councillors are not satisfied that there are appropriate measures being secured and therefore ask that the sale of the Fitties be aborted for the following reasons:

- Appropriate safeguards to address concerns on behalf of the tenants of the Fitties Chalet Park, have not been achieved in the opinion of the Ward Councillors.
- 2. In the interest of the Council's long-term finances.

Following a debate, a recorded vote was held in accordance with the requirements of the Councils Standing Orders, the votes cast were recorded as follows:
