#### NEL.151 APOLOGIES FOR ABSENCE

Apologies for absence from this meeting were received from Councillors Darby, McGilligan-Fell and Oxby.

#### NEL.152 **DECLARATIONS OF INTEREST**

Councillor Walker declared a disclosable pecuniary interest in item NEL.157 as a trustee of Lincs Inspire Limited.

Councillor Stockton declared a personal interest in any matters relating to his role as the vice-chairman of Centre 4.

# NEL.153 OUTCOMES FRAMEWORK, COMMISSIONING PLAN AND BUDGET 2017/18 – 2019/20

The Council received a report from the Portfolio Holder for Finance, Resources and Inclusion setting out the Council's Budget, Outcome Framework and Commissioning Plan for 2017/18 – 2019/20. This report had been considered by Cabinet at its meeting on 15<sup>th</sup> February, 2017 and the minutes of that meeting were circulated for members' reference.

Councillor Patrick, Portfolio Holder for Finance, Resources and Inclusion moved the recommendations as set out in the minutes of the Cabinet meeting.

Councillor Patrick highlighted the many challenges faced in setting the budget and the resulting unstinting focus on growth to achieve the best we can for the people and place of North East Lincolnshire. The budget was based on achieving growth in the council tax by developing housing, growth in the business rates by encouraging and developing our economy, and growth in community capacity by empowering our residents. Councillor Patrick provided examples of the Council's ambitions such as the SHIIP programme and stressed the importance of taking a long term view of financial planning and moving to an outcomes focus, working closely with partners. He reported on the plan for a creation of a community capacity fund, which would merge all ward funding into one single pot of monies, that all Councillors might apply to, with a specific aim of developing real community capacity. In support of community organisations such as In Bloom, he also reported that there would be an extra £30k added this year to the fund, which all community groups could bid for against a criteria of social return and Councillor Patrick acknowledged the efforts of a local capacity building. community group to keep the ice rink at the Grimsby Leisure Centre open and informed Council that funding would be made available to keep the ice rink open for a period of no less than six months and that support would be offered if a community asset transfer was sought by the group.

Councillor Watson, the Deputy Leader, seconded the budget proposals, noting the need to achieve sustainability through a budget built on growth.

Councillor Jackson, Leader of the Conservative Group, voiced his intent to oppose the budget. He supported the social care precept but not the remaining 1.98% increase as he felt that the administration had not driven change quickly enough nor maximised income opportunities through, for example, effective enforcement activities.

All Members had the opportunity to take part in the ensuing debate. Following the debate, the Mayor invited the Portfolio Holder for Finance, Resources and Inclusion to exercise his right of reply. The Mayor then put the budget recommendations to a recorded vote in accordance with the Constitution. The votes cast were recorded as follows:

#### RESOLVED -

- (1) That the 2017/18 Revenue Budget and summary Medium Term Financial Plan ('MTFP') for the period 2018/19 2019/20 contained within Appendix 1 and Annex 1 of the report now submitted, be approved.
- (2) That the creation of a £1m "Stronger Economies" capacity fund to enable economic growth for the period 2017/18 2018/19 be approved.
- (3) That the support for the Council's Outcomes Framework be reaffirmed.
- (4) That the Key Commissioning priorities and Commissioning briefs at Appendix 1 and Annex 2 within the report now supported, be approved.
- (5) That the additions to the 2017/18 2019/20 capital programme as set out in Annex 3 of the report now submitted, be approved.
- (6) That the use of reserves as set out in Annex 4 of the report now submitted, be approved.
- (7) That the uncertainty and increasing risk around the MTFP be noted and that the Director of Finance, Operations and Resources be requested to report back to Cabinet in respect of any material or significant variances against planning assumptions.
- (8) That the proposed 1.98% increase in Council Tax, be approved.

- (9) That the additional flexibility offered by DCLG relating to the Adult Social Care precept be noted and the increases re-phased to the precept as follows; 2017/18 3%, 2018/19 3%, 2019/20 0%.
- (10) That the delay in the publication of the final 2017/18 Local Government Finance Settlement be noted and request the Director of Finance, Operations and Resources to report back to Cabinet in respect of any material or significant variances against the assumptions contained within this report.
- (11) That a stronger communities capacity fund of £75k be established to replace the ward funding scheme and to include the opportunity for community groups to bid for capacity funding, subject to governance arrangements to be finalised by the Director of Finance, Operations and Resources, in consultation with the Leaders of the political groups and the Portfolio Holder for Finance, Resources and Inclusion.

There was a brief adjournment at this point to allow the final Council Tax resolution to be circulated.

#### NEL.154 **COUNCIL TAX 2017/2018**

Following the setting of the Revenue Budget for 2017/18, the Council considered the fixing of the Council Tax for the 2017/2018 financial year.

A recorded vote was taken in accordance with the Constitution and the votes cast were recorded as follows:

#### NEL.157 CALL IN - GRIMSBY ICE RINK

The Council considered a formal request from Members to call in a decision taken at Cabinet on 21<sup>st</sup> December, 2016 regarding the ice rink at Grimsby Leisure Centre. This matter was considered by the Tourism, Leisure and Culture Scrutiny Panel at its meeting on 25<sup>th</sup> January, 2017, and was referred to Council for further consideration of the proposed closure of the ice rink.

Councillor Hyldon-King, Portfolio Holder for Health and Well Being advised Council on the decision taken by Cabinet. She commented on the background to the decision and welcomed the pledge to allow the ice rink to remain open provided that all involved worked in partnership to resolve the issue. She emphasised the importance of getting the finances right.

Councillor Brookes, one of the members who had called in the decision, addressed Council. He welcomed the earlier pledge but moved an amendment that it be recommended to Cabinet that the ice rink be kept open until the community asset transfer had concluded. This was seconded by Councillor Jackson, who had also called the matter in.

Following a debate, the amendment was put to the vote. A recorded vote was requested, in accordance with the Constitution. The votes cast were recorded as follows:

RESOLVED – That it be recommended to Cabinet that the ice rink at Grimsby Leisure Centre be kept open until the community asset transfer process had concluded.
