

**PORTFOLIO HOLDER  
ENVIRONMENT, TRANSPORT AND ENERGY  
DECISION NOTICE**

At the meeting of the Portfolio Holder – Environment, Transport and Energy, held on the 11<sup>th</sup> June, 2018 the following matters were discussed. The decisions of the Portfolio Holder are set out below in each item along with reasons for the decision and other options considered.

**DNPH.ETE.01 DECLARATIONS OF INTEREST**

There were no declarations of interest made in regards to any items on the agenda.

**DNPH.ETE.02 LACEBY ROAD BUS SHELTER CONSULTATION**

The Portfolio Holder received a report to consider objections received in relation to the proposed bus shelter installation outside 110 Laceby Road, Grimsby and to seek approval for installation of the requested bus shelter.

**RESOLVED –**

- (1) That the result of the consultation undertaken in connection with the proposed bus shelter installation be considered.**
- (2) That a procurement exercise as defined within this report be undertaken.**
- (3) That the requested bus shelter be installed with a further report (to include consultation with local residents) to be submitted to the Portfolio Holder (six months from the bus shelter installation date).**

REASONS FOR DECISION – Following a request for a bus shelter at the bus stop outside 110 Laceby Road Grimsby, a public consultation exercise was conducted by the Local Authority with those residents who reside within a 50 metre radius of the proposed bus shelter.

OTHER OPTIONS CONSIDERED – Do not provide the bus shelter - This could disadvantage users of public transport in bad weather conditions and potentially discourage the use of local bus services.

#### **DNPH.ETE.03 TRACKING REPORT**

- (3) That in relation to DNPH.EE.23 (Petition for parking conditions on Bolingbroke Road, Cleethorpes) that it has been agreed that the potential TRO scheme will be implemented during the 2019/2020 financial year.**
- (4) That in relation to DNPH.EE.29 (Petition for parking restrictions, Anderson Street, Grimsby) that it has been agreed that the potential TRO scheme will be implemented during the 2019/2020 financial year.**
- (5) That in relation to DNPH.EE.30 (Petition for parking restrictions, Earl Street, Grimsby) that it has been agreed that**
